A RESOLUTION BY THE ATLANTA CITY COUNCIL INDICATING ITS CONTINUED SPIRITED SUPPORT OF THE INTENTION TO SELL AND/OR LEASE THE ATLANTA DETENTION CENTER TO FULTON COUNTY; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta and Fulton County governments are in the midst of fiscal and physical constraints that are impacting City and County operations, including the delivery of detention services; and

WHEREAS, consolidation of City and County detention service needs may decrease overall costs to the citizens of the City and Fulton County; and

WHEREAS, the previous City Council adopted resolution 09-R-1193 in June 2009 authorizing a City Negotiation Team to negotiate an agreement for the sale and/or lease of the Atlanta Detention Center to Fulton County or other interested parties; and

WHEREAS, the previous City Council adopted resolution 09-R-2196 December of 2009 indicating its support of the intention of the City selling or leasing the Atlanta Detention Center to Fulton County; and

WHEREAS, a new City Council has been elected and wishes to indicate its support of the sale or lease of the Atlanta Detention Center to Fulton County; and

WHEREAS, the City Negotiation Team has, and will continue to work in earnest with members of the Fulton County Commission for the sale and/or lease of the Atlanta Detention Center to Fulton County; and

WHEREAS, a final agreement with Fulton County has not yet been reached.

NOW THEREFORE BE IT RESOLVED: that the Council of the City of Atlanta, Georgia vigorously supports the continued negotiation and ultimate intention to sell and/or lease the Atlanta Detention Center to Fulton County.

BE IT FURTHER RESOLVED: that the City Negotiation Team, including the New Mayor is hereby authorized to cause the intended Agreement to be presented to the Atlanta City Council for approval such that execution of said Agreement be accomplished within the 1st quarter of 2010 or as soon as practicable thereafter.



BE IT FURTHER RESOLVED that the President shall appoint 4 members of the Atlanta City Council to serve on the negotiation team.

BE IT FURTHER RESOLVED that the appointed Council members shall report back to full Council after every meeting as to the negotiation team's progress

BE IT FINALLY RESOLVED: that all resolutions or parts of resolutions in conflict herewith are hereby waived to the extent of the conflict.
