

**AN ORDINANCE TO MAKE THE INTERSECTION OF GASKILL ST, S.E. AND

**WHEREAS**, the Department of Public Works received a request from the Cabbagetown Community Association to make the intersection of Gaskill Street, S.E. and Estoria Street, S.E. an all-way stop; and

**WHEREAS**, a traffic study revealed that the intersection meets the criteria to become an all-way stop.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS,**  
as follows:

**Section 1:** That the intersection of Gaskill Street, S.E. and Estoria Street, S.E. be made an all-way stop.

**Section 2:** That all existing ordinances or parts of ordinances in conflict with this ordinance shall be waived for the purposes of this ordinance only, and only to the extent of the conflict.
