**AN ORDINANCE
BY FINANCE/EXECUTIVE COMMITTEE**

AN ORDINANCE TO AMEND ARTICLE "V": CLASSIFICATION PLAN, SECTION 114-477, OF THE CODE OF ORDINANCES, SO AS TO PROVIDE ABOVE ENTRY HIRING AUTHORIZATION IN THE DEPARTMENT OF WATERSHED MANAGEMENT; AND FOR OTHER PURPOSES.
