AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO RENEWAL AGREEMENT NO. 1 FOR FC- 4718B, ANNUAL CONTRACT FOR SMALL WATER METERS FOR THE BUREAU OF DRINKING WATER WITH KEMI CONSTRUCTION, INC. ON BEHALF OF THE DEPARTMENT OF WATERSHED MANAGEMENT/BUREAU OF DRINKING WATER FOR TIME-ONLY; TO WAIVE ARTICLE X, SEC. 2-1188. COMPETITIVE SEALED BIDDING OF THE PROCUREMENT AND REAL ESTATE CODE OF THE CITY OF ATLANTA CODE OF ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta("City") entered into an Agreement for FC-4718B, Annual Contract for Small Water Meters for the Bureau of Drinking Water with Kemi Construction, Inc. pursuant to Resolution 08R1861; and

WHEREAS, the term of the agreement is for a period of one (1) year with two (2) one (1) year renewal options at the sole discretion of the City commencing January 5, 2009; and

WHEREAS, the Commissioner of the Department of Watershed Management recommends Renewal Agreement No. 1 for FC-4718B, Annual Contract for Small Water Meters for the Bureau of Drinking Water with Kemi Construction, Inc. for time-only.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby ordains:

SECTION 1:

That the Mayor is hereby authorized to enter into Renewal Agreement No. 1 for FC-4718B, Annual Contract for Small Water Meters for the Bureau of Drinking Water with Kemi Construction, Inc. for time-only.

SECTION 2:

That Article X, Sec. 2-1188. Competitive Sealed Bidding of the Procurement and Real Estate Code of the City of Atlanta Code of Ordinances is hereby waived and the term of Renewal Agreement No. 1 shall be from January 6, 2010 to January 5, 2011.

SECTION 3:

That the Chief Procurement Officer is directed to prepare an appropriate Agreement for execution by the Mayor.

SECTION 4:

That the Agreement will not become binding on the City, and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to Kemi Construction, Inc.

SECTION 5:

That all Ordinances or parts of Ordinances in conflict with this Ordinance are hereby waived to the extent of the conflict.
