**A SUBSTITUTE ORDINANCE
BY FINANCE/ EXECUTIVE COMMITTEE**

AN ORDINANCE TO AMEND THE FISCAL YEAR 2010 BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF FIFTEEN THOUSAND DOLLARS AND NO CENTS (\$15,000.00) FOR A DONATION RECEIVED FROM THE REED INAUGURAL COMMITTEE, INC. TO FUND CENSUS OUTREACH EFFORTS WITHIN THE CITY OF ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, the census is conducted every ten years as required by the Constitution of the United States (the "U.S."); and

WHEREAS, the census gathers important demographic information for communities throughout the U.S., which is used to determine, among other things, the level of federal funding communities receive for infrastructure and social services, as well as the number of seats each state has in the U.S. House of Representatives; and

WHEREAS, the City of Atlanta (the "City") desires to reach out to its citizens to inform them of the importance of completing and returning the 2010 census questionnaire; and

WHEREAS, local organizations and individuals have expressed an interest in making donations to fund the City's 2010 census outreach efforts; and

WHEREAS, a trust fund account has been established to receive and expend all donations for the 2010 census outreach efforts; and

WHEREAS, a donation in the amount of Fifteen Thousand Dollars and No Cents (\$15,000.00) has been received from the Reed Inaugural Committee, Inc.; and

WHEREAS, the donation must be anticipated and appropriated for the fiscal year 2010 budget.


THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:
