COMMITTEE**

**A RESOLUTION TO EXPRESS THE INTENT OF THE ATLANTA CITY COUNCIL TO PROVIDE THAT ALL POLICE POWER LICENSES, ZONING, AND VARIANCE APPLICATIONS CURRENTLY REQUIRED BY THE CITY OF ATLANTA CODE OF ORDINANCES TO BE PLACED ON THE AGENDA OF THE RELEVANT NEIGHBORHOOD PLANNING UNIT ("NPU") ARE ALSO PLACED ON THE AGENDA OF THE ADJACENT NPU(S); TO CREATE A TASK FORCE TO RECOMMEND CHANGES TO THE CITY OF ATLANTA CODE OF ORDINANCES TO ACHIEVE SAID INTENT; AND FOR OTHER PURPOSES.**

**WHEREAS**, certain police power licenses and all rezoning and variance applications must be placed on the agenda of the relevant neighborhood planning unit for advisory purposes; and

**WHEREAS**, if approved, the impact of such applications extend beyond the boundary of the relevant NPU; and

**WHEREAS**, to ensure that impacted neighborhoods are able to hear, respond to and advise the City on such applications; and

**WHEREAS**, it is the intent of the City Council to create a task force composed of members of the Atlanta Police Department, Bureau of Planning, Department of Law, individual NPUs and the Atlanta Planning Advisory Board to make recommendations.

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES** its intent to provide that all police power licenses, zoning, and variance applications required by the City of Atlanta Code of Ordinances to be placed on the agenda of the relevant Neighborhood Planning Unit ("NPU") are also placed on the agenda of the adjacent neighborhood planning unit and to create a task force to recommend changes to the City of Atlanta Code of Ordinances to achieve said intent.

**BE IT FINALLY RESOLVED:** that all resolutions or parts of resolutions in conflict herewith are hereby waived to the extent of the conflict.
