**PAN AMENDED RESOLUTION

**AUTHORIZING THE MAYOR TO ENTER INTO RENEWAL AGREEMENT NO. 1 FOR FC-6007000029, ANNUAL CONTRACT FOR MAJOR MECHANICAL SERVICES WITH ALBERICI CONSTRUCTORS, INC./WILLIS PROFESSIONAL SERVICES, JV FOR TIME-ONLY; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta ("City") did enter into an Agreement FC-6007000029, Annual Contract for Major Mechanical Services for the Bureau of Wastewater Treatment and Collections, with Alberici Constructors, Inc./Willis Professional Services, JV pursuant to Resolution 07-R-0750; and

**WHEREAS**, the term of the agreement is for a period of two (2) years with two (2) one (1) year renewal options; and

**WHEREAS**, the City did enter into Amendment Agreement No. 1 to add the second year funding in an amount not to exceed One Million Ten Thousand Dollars (\$1,010,000.00) pursuant to Resolution 09-R-1666; and

**WHEREAS**, the Commissioner of the Department of Watershed Management and the Chief Procurement Officer recommend Renewal Agreement No. 1 for FC-6007000029, Annual Contract for Major Mechanical Services with Alberici Constructors, Inc./Willis Professional Services, JV for time-only.

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor is hereby authorized to enter into Renewal Agreement No. 1 for FC-6007000029, Annual Contract for Major Mechanical Services for the Bureau of Wastewater Treatment and Collections, with Alberici Constructors, Inc./Willis Professional Services, JV for time-only.

**BE IT FURTHER RESOLVED**, that the term of Renewal Agreement No. 1 will be from April 16, 2010 through April 15, 2011.

**BE IT FURTHER RESOLVED**, that the Chief Procurement Officer is directed to prepare an appropriate Agreement for execution by the Mayor.

**AND FINALLY BE IT RESOLVED** that the Agreement will not become binding on the City, and the City will incur no obligation or liability under it until it has been approved as to form by the City Attorney, executed by the Mayor, attested to by the Municipal Clerk, and delivered to Alberici Constructors, Inc./Willis Professional Services, JV.
