

Overall Cost Estimate for Council Strategic Plan Development and Implementation

Retreat TOTAL ESTIMATE = 18 hrs @ \$200/hr = \$3,600

Printing and chain take-away and Parking for meetings cost estimate = \$200.

Retreat TOTAL OVERALL = \$4,322
