**WHEREAS,** Rev. James Orange was an avid member of the Southern Christian Leadership Conference (SCLC); and

**WHEREAS,** SCLC was inadvertently omitted from the organizations named in Resolution 10-R-0223 which are to make appointments to the commission to determine an appropriate honor memorializing Reverend James Orange in the City of Atlanta; and

**WHEREAS,** the Atlanta City Council wishes to correct this oversight.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**Section 1:** That the commission created to determine an appropriate honor to memorialize Rev. James Orange in the City of Atlanta be expanded to include a member to be appointed by the local chapter of the Southern Christian Leadership Conference (SCLC), thus increasing the commission's membership to 16.

**Section 2:** All resolutions or parts of resolutions in conflict herewith are hereby rescinded.
