

**AN ORDINANCE RESCINDING ORDINANCE NUMBER 09-O-0660 ADOPTED BY COUNCIL ON DECEMBER 7, 2009 AND APPROVED BY THE MAYOR ON DECEMBER 15, 2009 AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE FY 2010 BUDGET (5057) (2001 WATER AND WASTEWATER FUND) IN THE AMOUNT OF TWELVE MILLION TWO HUNDRED SIXTY NINE THOUSAND SEVEN HUNDRED THIRTY FIVE DOLLARS AND TWENTY ONE CENTS (\$12,269,735.21); TO TRANSFER FUNDS FROM THE COMPLETED, REALIGNED, POSTPONED OR DISCONTINUED PROJECTS TO THE CAPITAL PROJECTS RESERVE FOR APPROPRIATIONS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta owns and operates a water and wastewater system; and

**WHEREAS**, the City of Atlanta, Department of Watershed Management has requested rescinding 09-O-0660 because the decision has been made not to reprogram these funds; and

**WHEREAS**, these funds should remain in the projects identified in ordinance 09-O-0660.

**THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:**

**Section 1:** That Ordinance 09-O-0660 is hereby rescinded.

**Section 2:** That all ordinances and parts of ordinances in conflict with the terms contained herein are hereby waived to the extent of the conflict.
