**A RESOLUTION APPOINTING COUNCIL MEMBER C. T. MARTIN TO
THE COMPENSATION COMMITTEE REESTABLISHED BY
ORDINANCE # 10-O-0225; AND FOR OTHER PURPOSES.**

WHEREAS, the Compensation Committee reestablished by Ordinance # 10-O-0225 provides that one of the members of the committee be a member of the council selected by the council; and

WHEREAS, the City Council President and all Council Members were notified of this vacancy and were requested to submit the names of nominees for this position; and

WHEREAS, although no names of nominees were submitted, Councilman C. T. Martin volunteered to serve as the city council member appointee to the committee; and

WHEREAS, pursuant to City Code Section 2-1852, where there is only one vacancy and one nominee, a resolution shall be prepared naming that individual for appointment to the vacant position and submitted to the committee of purview for its consideration and recommendation, and then forwarded to the Committee on Council, and ultimately, to the full council for action; and

WHEREAS, City Code Section 2-1852 also provides that by two-thirds vote of the total membership of the council, the council may waive the requirements of this ordinance and consider the appointment at the same meeting at which it is introduced, sounded or announced. Action on the appointment shall only require a simple majority vote; and

WHEREAS, this appointment needs to be made expeditiously and the committee vetting process should be waived.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Council Member C. T. Martin is hereby selected to serve as a member of the Compensation Committee reestablished by Ordinance # 10-O-0225, said appointment to begin on the date of the approval of this Resolution.
