AN ORDINANCE BY COMMITTEE ON COUNCIL

TO AMEND THE 2001 CITY OF ATLANTA PRECINCTS AND POLLING PLACES IN PRECINCTS 01C, 01S, 02A, 02J, 03C, 03H, 05B, 08E, 09F, 10P, 11A1, 11A2, 11A3 AND 11N TO MAKE PERMANENT OR TEMPORARY RELOCATIONS AS A RESULT OF UNAVAILABILITY OF VOTING FACILITY, SCHEDULED OR COMPLETED RENOVATIONS; AND FOR OTHER PURPOSES.

WHEREAS, the 2001 Precincts and Polling Places Ordinance, dated October 24, 2001, was adopted November 5, 2001, and;

WHEREAS, such Precincts and Polling Places Ordinance has previously been amended by action of the City Council on May 20 2002, July 15 2002, September 3 2002, October 21 2002, November 18 2002, September 15 2003, October 20 2003, April 19 2004, July 19 2004, November 01 2004, September 06 2005, November 07 2005, June 05 2006, July 05 2006, September 05 2006, October 02 2006, December 04 2006, February 05 2007, March 19 2007, May 21 2007, September 04 2007, January 22 2008, July 07 2008, November 03 2008, May 04 2009, June 01 2009, August 17 2009 and October 19 2009 and;

WHEREAS, the Fulton County Board of Registration and Elections has approved changes to City of Atlanta Precincts/Polling Places 01C, 01S, 02A, 02J, 03C, 03H, 05B, 08E, 09F, 10P, 11A1, 11A2, 11A3 and 11N to make permanent or temporary relocations as a result of unavailability of voting facility and scheduled or completed renovations and;

WHEREAS, all affected voters will be notified of these changes by the Fulton County Office of Registration and Elections accordingly and;

WHEREAS, the governing authority of the City of Atlanta, the Atlanta City Council, believes that ratification of these changes should be made by this Body.

NOW THEREFORE BE IT ORDAINED that the Atlanta City Council does hereby ratify the previous authorization and approval by the Fulton County Board of Registration and Elections of the polling place changes in Precincts **01C, 01S, 02A, 02J, 03C, 03H, 05B, 08E, 09F, 10P, 11A1, 11A2, 11A3 and 11N** within the City of Atlanta/Fulton County; and

BE IT FINALLY ORDAINED that the Atlanta City Council does hereby Amend the 2001 Precincts and Polling Places Ordinance, dated October 24, 2001, and Adopted November 5, 2001 which was codified as Section 66-2 of the City of Atlanta Code of Ordinances and adopted by reference, by adding the recent changes to Precincts/Polling Places **01C, 01S, 02A, 02J, 03C, 03H, 05B, 08E, 09F, 10P, 11A1, 11A2, 11A3 and 11N** to make permanent or temporary relocations as a result of unavailability of voting facility and scheduled or completed renovations; all of which is reflected or incorporated in the April 19, 2010 Revision to the 2001 Precincts and Polling Places Ordinance identified as Attachment I to this ordinance, with certain particular changes described by the further attachment identified as, **Exhibits A, B, C, D, E, F, G, H, I, J, K and L**, all being made a part hereof and noted as follows:



SECTION 1. To amend **Precinct/Polling Place 01C located at Church of Greater Works, 1800 Jonesboro Rd., S. E.** by permanently moving said precinct and combining with Precinct 01S located at **Dobbs Elementary School, 2025 Jonesboro Rd., S. E.** due to prohibited rental costs as identified in Exhibit A (Pages 1-3). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 1). Voters will be notified of their voting location by first-class mail.

SECTION 2. To amend **Precinct/Polling Place 01S located at Paul L. Dunbar School, 660 McWilliams Rd., S. E.** by permanently moving said precinct to **Dobbs Elementary School, 2025 Jonesboro Rd., S.E.** due to scheduled renovations as identified in Exhibit B (Pages 1-2). The proposed facility is accessible to the disabled and is less than two miles from the existing facility. The new polling place is indicated in Attachment I (page 2). Voters will be notified of their voting location by first-class mail.

SECTION 3. To amend **Precinct/Polling Place 02A located at Palmer House, 430 Centennial Olympic Park Dr., N. W.** by permanently moving said precinct to **Centennial YMCA, 555 Lucky St., N. W.** due to the facility no longer being available for voting as identified in Exhibit C (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 16). Voters will be notified of their voting location by first-class mail.

SECTION 4. To amend **Precinct/Polling Place 02J located at Dunbar Neighborhood Center, 477 Windsor St., S. W.** by moving said precinct back to its original facility located at **Paul L. Dunbar School, 500 Whitehall Terrace, S. W.** due to renovations having been completed as identified in Exhibit D (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 4). Voters will be notified of their voting location by first-class mail.

SECTION 5. To amend **Precinct/Polling Place 03C located at Turner Middle School, 98 Anderson Ave., N. W.** by temporarily moving said precinct to **Anderson Park, 98 Anderson Ave., N. W.** due to scheduled renovations as identified in Exhibit E (Pages 1-2). The proposed facility is accessible to the disabled and is on the same premises as the existing facility. The new polling place is indicated in Attachment I (page 5). Voters will be notified of their voting location by first-class mail.

SECTION 6. To amend **Precinct/Polling Place 03H located at Walter F. White School, 1890 Detroit Ave., N. W.** by temporarily moving said precinct to **Allen Temple AME Church, 1625 Joseph Boone Blvd., N. W.** due to scheduled renovations as identified in Exhibit F (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 6). Voters will be notified of their voting location by first-class mail.



SECTION 7. To amend **Precinct/Polling Place 05B located at Cook Elementary School, 211 Memorial Dr., S. E.** by temporarily moving said precinct to **Columbia Village Sr. Residence, 125 Logan St., S. E.** due to scheduled renovations as identified in Exhibit G (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 10). Voters will be notified of their voting location by first-class mail.

SECTION 8. To amend **Precinct/Polling Place 08E located at Mt. Paran Church of God, 2055 Mt. Paran, Rd., N. W.** by moving said precinct back to its original facility **located at Morris Brandon Primary Center School, 2845 Margaret Mitchell Dr., N. W.** due to renovations having been completed as identified in Exhibit H (Pages 1-2). The proposed facility is accessible to the disabled and is approximately three and one half miles from the existing facility. The new polling place is indicated in Attachment I (page 16). Voters will be notified of their voting location by first-class mail.

SECTION 9. To amend **Precinct/Polling Place 09F located at Bolton Academy, 2268 Adams Dr., N. W.** by moving said precinct back to its original facility **located at Pace Academy Athletic Facility, 2465 Warren Rd., N. W.** due to renovations having been completed as identified in Exhibit I (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 18). Voters will be notified of their voting location by first-class mail.

SECTION 10. To amend **Precinct/Polling Place 10P located at Towns Elementary School, 760 Bolton Rd., N. W.** by temporarily moving said precinct to **Pleasant Hill Baptist Church, 745 Bolton Rd., N. W.** due to scheduled renovations as identified in Exhibit J (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 21). Voters will be notified of their voting location by first-class mail.

SECTION 11. To amend **Precinct/Polling Places 11A1, 11A2 and 11A3 located at Zion Hill Baptist Church, 815 Lynhurst Dr., S. W.** by moving said precincts back to its original facility **located at Young Middle School, 3116 Benjamin E. Mays Dr., S. W.** due to renovations having been completed as identified in Exhibit K (Pages 1-2). The proposed facility is accessible to the disabled and is located less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 22). Voters will be notified of their voting location by first-class mail.

SECTION 12. To amend **Precinct/Polling Place 11N located at D. M. Therrell High School, 3099 Panther Trail., S. W.** by temporarily moving said precinct to **Kimberly Elementary School, 3090 McMurray Dr., S. W.** due to scheduled renovations as identified in Exhibit L (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 24). Voters will be notified of their voting location by first-class mail.

SECTION 13. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.






FIGURE 08 PRECINCT 02J EXISTING & PROPOSED



FIGURE 10 PRECINCT 03C EXISTING & PROPOSED








