AN ORDINANCE TO AMEND CHAPTER 2 (ADMINISTRATION), ARTICLE XVI (BOARDS, COUNCILS, COMMISSIONS AND AUTHORITIES), DIVISION 5 (ADVISORY COMMITTEE ON INTERNATIONAL RELATIONS [ACIR]), SECTION 2-1981 (a)(2)(ESTABLISHED, COMPOSITION) OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA, GEORGIA SO AS TO ALLOW THE PRESIDENT OF THE COUNCIL, IN ADDITION TO APPOINTING ONE (1) MEMBER OF THE COUNCIL WHO SHALL SERVE AS CHAIRPERSON OF ACIR, THE DISCRETION TO APPOINT OTHER MEMBERS OF THE COUNCIL AS NONVOTING MEMBERS OF ACIR; TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, ACIR and the president of the council, desire to allow more flexibility in the appointment of council members to ACIR; and

WHEREAS, increasing the number of council members who serve on the ACIR, will allow more council members to become engaged in the activities of Atlanta's international community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1. Chapter 2 (Administration), Article XVI (Boards, Councils, Commissions and Authorities), Division 5 (Advisory Committee on International Relations [ACIR]), Section 2-1981 (a) (2) (Established, composition) of the Code of Ordinances of the City of Atlanta, Georgia, which currently provides as follows:

Sec. 2-1981. Established, composition.

- (a) There is established an advisory committee on international relations, which shall consist of:
- (2) One member of the council to be appointed as chairperson by the president of the council; and

Is hereby amended by deleting the current subsection (2) and by replacing said subsection with the following:

- (2) One member of the council to be appointed as chair by the president of the council; the president of the council may appoint other council members as non-voting members; and

Section 2. All ordinances or parts of ordinances in conflict with this ordinance are hereby waived to the extent of any such conflict.
