




**AN ORDINANCE BY  
TRANSPORTATION COMMITTEE**

**AN ORDINANCE TO RESTRICT PARKING ON A CERTAIN SECTION OF  
BELMONT AVENUE, S.W.; AND FOR OTHER PURPOSES.**

**WHEREAS**, the Department of Public Works (“Department”) received a request to restrict parking near 1503 Belmont Avenue S.W.; and

**WHEREAS**, the Department has made an assessment of Belmont Avenue, S.W. which is approximately 26 feet wide and recommends the implementation of parking restrictions on both sides of Belmont Avenue, S.W. beginning at the intersection of Belmont Avenue, S.W. and Deckner Avenue S.W. in a southerly direction for approximately 110 feet; and

**WHEREAS**, the installation of this parking restriction should not create hardship to nearby residents as parking is not restricted on the remaining segment of Belmont Avenue and Deckner Avenue.

**NOW, THEREFORE, THE CITY COUNCIL OF THE ATLANTA, GEORGIA, HEREBY  
ORDAINS, as follows:**

**Section 1:** That parking restrictions be implemented on both sides of Belmont Avenue, S.W. beginning at Deckner Avenue, S.W. for approximately 110 feet south of Deckner Avenue, S.W (as reflected in the attached Exhibit “A”).

**Section 2:** That all existing ordinances or parts of ordinances in conflict with this ordinance shall be waived for the purposes of this ordinance only, and only to the extent of the conflict.


