RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO VARIOUS CONTRACTUAL AGREEMENTS ADMINISTERED BY THE OFFICE OF HUMAN SERVICES FOR PROJECTS UNDER THE 2010 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), 2010 EMERGENCY SHELTER GRANT (ESG), 2010 HOME INVESTMENT PARTNERSHIP ACT (HOME) AND 2010 HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA); AND FOR OTHER PURPOSES

WHEREAS, projects to support services for the homeless and persons with HIV/AIDS were approved in the 2010 Annual Action Plan for the Community Development Block Grant (CDBG), Emergency Shelter Grant (ESG), HOME Investment Partnership Act (HOME) and Housing Opportunities for Persons with AIDS (HOPWA) programs; and

WHEREAS, the City has obtained release of funds from the U.S. Department of Housing and Urban Development (HUD) for these projects, based on the filing of environmental clearances.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That the Mayor or her designee be and is authorized hereby to enter into contractual agreements for the following Community Development Block Grant (CDBG), Emergency Shelter Grant (ESG), HOME Investment Partnership Act (HOME), and the Housing Opportunities for Persons with AIDS (HOPWA) projects:


