**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that Ms. Marion Cameron, CPA, is hereby appointed to the City of Atlanta Audit Committee, said appointment to begin on the date of the adoption of this Resolution.**
