A RESOLUTION TO CONFIRM THE APPOINTMENT OF SIGRID EHRMANN READ TO THE CAMPBELLTON ROAD TAX ALLOCATION DISTRICT ADVISORY COMMITTEE; AND FOR OTHER PURPOSES.

WHEREAS, Ordinance 06-O-2292 (the "Ordinance"), adopted by City Council on November 20, 2006 and approved by the Mayor on November 28, 2006 authorized, among other things, the creation of the City of Atlanta Tax Allocation District Number Seven- Campbellton Road TAD; and

WHEREAS, Section 8 of the Ordinance authorized the Atlanta Development Authority to establish an advisory committee to make recommendations on projects to be funded from bond proceeds, tax allocation increment or other funds generated by the Campbellton Road TAD; and

WHEREAS, Resolution 09-R-1939, adopted by City Council on November 2, 2009 and approved on November 11, 2009 pursuant to Section 2-403 of the City Charter, authorized the establishment of the Campbellton Road TAD Advisory Committee (the "Advisory Committee"); and

WHEREAS, pursuant to Resolution 09-R-1939 the Advisory Committee shall consist of Chairs of Neighborhood Planning Units P, R, S and X or their designees, a Fort McPherson Redevelopment Authority designee and business representatives, all of whom must be confirmed by Council; and

WHEREAS, Resolution 09-R-1939 further provides that the NPU representatives to the Advisory Committee shall be selected annually by the respective NPUs and shall be confirmed by City Council; and

WHEREAS, the City desires to confirm the selection of Sigrid Ehrmann Read, Treasurer of NPU "X" to serve on the Advisory Committee.

THE CITY COUNCIL OF THE CITY OF ATLANTA GEORGIA HEREBY RESOLVES, that the selection of Sigrid Ehrmann Read to serve on the Campbellton Road TAD Advisory Committee for a period of one year is hereby confirmed.

BE IT FURTHER RESOLVED, that all resolutions and parts of resolutions in conflict herewith are hereby waived to the extent of the conflict.
