




FC-6007000058, POST-PRODUCTION SUPPORT FOR ENTERPRISE RESOURCE PLANNING, WITH ORACLE USA, INC., FOR ONE (1) YEAR PENDING COMPLETION OF A COMPETITIVE PROCUREMENT PROCESS, ON BEHALF OF THE DEPARTMENT OF INFORMATION TECHNOLOGY, IN AN AMOUNT NOT TO EXCEED ONE MILLION, EIGHT HUNDRED FIFTY THOUSAND DOLLARS AND NO CENTS (\$1,850,000.00) STARTING JULY 1, 2010; ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM FUND, DEPARTMENT, ORGANIZATION AND ACCOUNT NUMBER 1001 (GENERAL FUND) 050207 (IT STRATEGIC SERVICES) 5213001 (CONSULTING/PROFESSIONAL SERVICES-TECHNICAL) 1535000 (DATA PROCESSING/MANAGEMENT INFORMATION SYSTEMS); AND FOR OTHER PURPOSES.**


**WHEREAS**, the City of Atlanta ("City") entered into Contract No. FC-6007000058, Post-Production Support for Enterprise Resource Planning ("ERP") Program with Oracle USA, Inc. ("Oracle"), for a term of one (1) year, in an amount not to exceed Two Million, Five Hundred Thousand Dollars and No Cents (\$2,500,000.00) pursuant to Resolution 07-R-2542; and

**WHEREAS**, the Contract was extended six (6) months from January 1, 2009 to June 30, 2009 in an amount not to exceed One Million, Two Hundred Fifty Thousand dollars and no cents (\$1,250,000.00) with an option to renew for an additional six (6) months to obtain additional consulting and professional services for the City's implemented ERP system pursuant to Ordinance 08-O-2351; and

**WHEREAS**, the City Council authorized an additional six (6) month extension with a six (6) month renewal option for performance of additional services in the amount of Nine Hundred Seventy-Five Thousand Dollars and No Cents (\$975,000.00) pursuant to Resolution 09-OR-1081; and

**WHEREAS**, the City executed an additional six (6) month renewal option for performance of additional services in the amount of Nine Hundred Seventy-Five Thousand Dollars and No Cents (\$975,000.00) pursuant to Resolution 09-OR-2020; and

**WHEREAS**, the Department of Information Technology and the Chief Procurement Officer recommend extending the contract for one (1) year, pending the completion a competitive procurement process, effective July 1<sup>st</sup>,



2010 in an amount not to exceed One Million, Eight Hundred Fifty Thousand Dollars And No Cents (\$1,850,000.00).

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:**

**SECTION 1:** that the Mayor or his designee is authorized to extend the contract with Oracle for Post-Production Support services pursuant to the same terms and conditions previously approved by this Council.

**SECTION 2:** that the cost of the Post-Production Support services shall not exceed One Million, Eight Hundred Fifty Thousand Dollars And No Cents (\$1,850,000.00) and all contracted work will be charged to and paid from Fund, Department Organization and Account number 1001 (General Fund) 050207 (IT Strategic Services) 5213001 (Consulting/Professional Services-Technical) 1535000 (Data Processing/Management Information Systems).

**SECTION 3:** that the services will be performed for one (1) year effective July 1, 2010 pending completion of a competitive procurement process.


**SECTION 4:** that the Chief Procurement Officer is directed to assist the City Attorney in the preparation of the extension for execution by the Mayor.

**SECTION 5:** that the agreement will not become binding on the City, and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney, and delivered to Oracle.

**SECTION 6:** that Article X, Section 2-1206 (relating to extension and expiration of contracts) of the City of Atlanta's Code of Ordinances is hereby waived to the extent that such applies to the extension of contracts.

**SECTION 7:** that all Ordinances or parts of Ordinances in conflict with this Ordinance are waived for this instance only.
