AN ORDINANCE

BY FINANCE/ EXECUTIVE COMMITTEE

AN ORDINANCE TO AMEND THE 2010 TRUST FUND BUDGET, DEPARTMENT OF FINANCE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF TWENTY-TWO THOUSAND SEVEN HUNDRED FORTY FOUR DOLLARS AND NO CENTS (\$22,744.00) FOR COSTS RELATED TO ENVIRONMENTAL REVIEWS PERFORMED ON BEHALF OF THE ATLANTA HOUSING AUTHORITY; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Housing Authority (“AHA”) is authorized under Georgia law to utilize federal financial assistance for projects and activities for public housing development; and

WHEREAS, in order for certain projects to move forward, AHA must have environmental reviews completed pursuant to regulations set forth by the U.S. Department of Housing and Urban Development (“HUD”), 24 C.F.R. Part 58; and

WHEREAS, to expedite project development, AHA has asked the City to act as the non-recipient responsible entity for AHA projects that require environmental reviews; and

WHEREAS, Resolution 07-R-0770 authorized the Mayor to enter into an Intergovernmental Agreement (“IGA”) with AHA, for the performance of environmental reviews as required by HUD; and

WHEREAS, the IGA is for a period of one year with the option to extend the IGA for four additional one-year periods; and

WHEREAS, the City has received funds in an amount not to exceed Twenty-Two Thousand Seven Hundred Forty Four Dollars and No Cents (\$22,744.00) from AHA for reasonable costs incurred in performing environmental reviews for AHA projects and programs, and desires to anticipate and appropriate these funds to the trust account created for these funds from AHA.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2010 (Trust Fund) Budget, Department of Finance, is hereby amended as follows:


