**AN ORDINANCE

AS SUBSTITUTED BY FINANCE/ EXECUTIVE COMMITTEE

AN ORDINANCE AMENDING THE 2010 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS AND DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$39,494.00 FOR A GRANT AWARD FROM THE GOVERNOR’S OFFICE FOR CHILDREN AND FAMILIES FOR THE IMPLEMENTATION OF THE ATLANTA GUN VIOLENCE PREVENTION PROGRAM; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) applied for block grant funding from the Governor’s Office for Children and Families to fund the Atlanta Gun Violence Prevention program; and

WHEREAS, in response to its application, the City has received an award in the amount of \$39,494.00; and

WHEREAS, the funds will be used for the implementation of the Atlanta Gun Violence Program, which is aimed at providing constructive alternatives to crime for youths in the community and enhancing PAL programs; and

WHEREAS, the City desires to anticipate and appropriate the grant funds in the amount of \$39,494.00.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2010 (Intergovernmental Grant Fund) Budget, Department of Parks Recreation and Cultural Affairs and Department of Police, is hereby amended as follows:
