AN ORDINANCE TO AMEND THE CODE OF THE CITY OF ATLANTA, GEORGIA, BY AMENDING SEC. 2-343 AND SECTION 114-101., TO REQUIRE THE SUBMISSION OF LEGISLATION IN SUPPORT OF THE PROPOSED ANNUAL BUDGET BE MADE TO THE CITY COUNCIL AT THE SAME TIME THAT THE PROPOSED BUDGET IS SUBMITTED, TO REPEAL CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, Section 6-302. Adoption of budget, of the City Charter requires that “the mayor shall prepare and submit the proposed annual budget ordinance to the governing body no later than the first regular meeting of the governing body in May, preceding the commencement of the fiscal year”; and

WHEREAS, in conjunction with the proposed budget, the Administration may propose additional legislation, including but not limited to ordinances to increase fees or taxes, ordinances to reorganize the administrative government structure and ordinances to authorize personnel actions, which would be best served if submitted for consideration by the Council along with the proposed budget; and

WHEREAS, the City Council desires to ensure that it has the greatest opportunity to consider and deliberate on legislation submitted in support of the mayors proposed budget; and

WHEREAS, the City Council desires that the mayor submit legislation needed to support the proposed budget at the same time that the proposed budget is submitted.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

SECTION 1: That Section 2-343 be amended to read as follows:

Sec. 2-343. Copy of proposed budget **and supporting legislation** furnished to Councilmembers prior to submission for adoption.



It shall be the duty of the chief financial officer to furnish each member of the council a complete detailed copy of the proposed annual budget and legislation designed to support the proposed annual budget at least five days before the budget is submitted to the council for adoption.


SECTION 2: That Section 114-101 be amended to read as follows:

Sec. 114-101. Objective and use.

- (a) The classification plan shall constitute a systematic arrangement and inventory of positions in the civil service whereby positions shall be grouped into classes indicative of the range of duties, responsibilities and level of work performed. The plan shall be utilized in order to provide a systematic salary structure which shall be commensurate with the duties of the positions established while being consistent with the fiscal integrity of the city. The classification plan shall be based on job analysis and maintained on a current basis.
- (b) **Changes to the classification plan proposed in conjunction with and as a part of the mayors proposed annual budget shall be submitted to Council for consideration at the same time that the proposed annual budget is submitted.**
- (c) **In addition to the legislation, identified in Subsection (b), a copy of an organization chart for the city department(s) or unit(s) for which the changes are being proposed shall be included as an "Exhibit" to the legislation.**

SECTION 3: That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
