A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO A CONTRACTUAL AGREEMENT WITH CSX TRANSPORTATION INC., A VIRGINIA CORPORATION, ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS, TO PROVIDE CONSTRUCTION SERVICES FOR THE BOULEVARD SIDEWALK PROJECT IN AN AMOUNT NOT TO EXCEED TWELVE THOUSAND THIRTY SIX DOLLARS (\$12,036.00); WITH ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM VARIOUS FUND, DEPARTMENT ORGANIZATION AND ACCOUNT NUMBERS; AND FOR OTHER PURPOSES.

WHEREAS, CSX Transportation Inc. (“CSXT”) is the approving authority for construction contract documents including design drawings and technical specifications for construction projects which cross or impact CSXT right of way; and

WHEREAS, the City of Atlanta (“City”) and CSXT propose to enter into an Agreement (herein attached as Exhibit “A”) for construction services for sidewalk improvements along Boulevard SE from Hamilton Avenue SW to north of the CSXT tracks in the City; and

WHEREAS, CSXT will provide and install rubber interface material and clamps within their rail right of way; and

WHEREAS, this project will provide increased pedestrian safety to residents of the city, as well as visitors traveling this route by providing an ADA compliant walk across the CSXT right of way; and

WHEREAS, the Commissioner of the Department of Public Works and the Chief Procurement Officer have recommended this contractual Agreement be approved in an amount not to exceed Twelve Thousand Thirty Six Dollars (\$12,036.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or his designee is authorized to enter into an appropriate contractual agreement with CSX Transportation Inc. on behalf of the Department of Public Works, to provide construction services in an amount not to exceed Twelve Thousand Thirty Six Dollars (\$12,036.00).


BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare an appropriate Agreement for execution by the Mayor.
