**A RESOLUTION AUTHORIZING THE CHIEF FINANCIAL OFFICER TO REFUND \$96,248.00 TO SUNNY COMMUNICATIONS LOCATED AT 3568 PEORIA ST. UNIT 608, AURORA, COLORADO, FOR PAYMENTS MADE TOWARDS SURPLUS RADIOS NOT WITHIN THE CITY OF ATLANTA'S INVENTORY; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta upgraded from an analog to a digital public safety radio communications system in 2007; and

**WHEREAS**, as a result of the upgrade to the digital public safety radio system, the City had surplus analog radios; and

**WHEREAS**, Sunny Communications, located at 3568 Peoria St., Unit 608 Aurora, Colorado, contracted with the City to purchase 5,049 surplus analog radio units and other equipment for a total cost of \$250,060.00; and

**WHEREAS**, the final inventory count for the surplus radios was 2,163 less than what was previously anticipated; and

**WHEREAS**, Sunny Communications forwarded payment in anticipation of receiving said radios; and

**WHEREAS**, Sunny Communications has requested a refund for the purchase price of the radios not provided; and

**WHEREAS**, the Office of Revenue has determined that Sunny Communications is entitled to a refund in the amount of \$96,248.00 for payments made towards surplus radios not within the City of Atlanta's inventory; and

**WHEREAS**, payment was placed in a temporary holding account, and not encumbered by the General Fund; and

**WHEREAS**, all refunds in excess of five thousand dollars (\$5,000.00) require approval through legislation before any funds can be disbursed.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES**, that the Chief Financial Officer is hereby directed to issue a refund to Sunny Communications in the amount of \$96,248.00, which represents the amount for payments made towards surplus radios not within the City of Atlanta's inventory.

**BE IT FURTHER RESOLVED**, that all funds shall be charged and paid from Fund Department Organization Account Number 1001 (General Fund) 000001 (Balance Sheet Org) 1226004 (Deposits & Advances) in the amount of \$96,248.00.



**BE IT FINALLY RESOLVED**, that all the resolutions and parts of resolutions in conflict herewith are hereby waived to the extent of the conflict.
