

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE RENEWAL AND AMENDMENT NUMBER 1 WITH CADUCEUS OCCUPATIONAL MEDICINE FOR FC-6006007902, PRE-EMPLOYMENT PHYSICALS, ON BEHALF OF THE DEPARTMENT OF HUMAN RESOURCES, IN AN AMOUNT NOT TO EXCEED THREE HUNDRED NINETY-NINE THOUSAND SEVEN HUNDRED TWENTY-FIVE DOLLARS AND NO CENTS (\$399,725.00); ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM FUND, DEPARTMENT ORGANIZATION AND ACCOUNT NUMBERS 5051 (WATER AND WASTEWATER REVENUE FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212003 (MEDICAL SERVICES PROVIDER) (\$45,216.00); 5501 (AIRPORT REVENUE FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212003 (MEDICAL SERVICES PROVIDER) (\$38,280.00); 6002 (GROUP INSURANCE FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212003 (MEDICAL SERVICES PROVIDER) (\$298,000.00); 1001 (GENERAL FUND) 230203 (AFR FIRE EMERGENCY MEDICAL SERVICES) 5212001 (CONSULTANT SERVICES) (\$18,229.00); AND FOR OTHER PURPOSES.

WHEREAS, on April 25, 2007 the City of Atlanta ("City") entered into an Agreement with Caduceus Occupational Medicine, for FC-6006007902, Pre-Employment Physicals, pursuant to Resolution 07-R-0079 adopted by the Atlanta City Council on January 16, 2007 and approved by the Mayor on January 22, 2007; and

WHEREAS, the Agreement is for a period of three (3) years with two (2) one-year renewal option at the City's sole discretion; and

WHEREAS, pursuant to Code Section 2-1206, the City's Chief Procurement Officer extended the Agreement for an additional 90 days, resulting in a current expiration date of July 23, 2010; and

WHEREAS, Caduceus Occupational Medicine has performed the contracted services satisfactorily; and

WHEREAS, the City desires to exercise its first option to renew the Agreement for an additional one-year period, commencing effective July 24, 2010, through July 23, 2011; and

WHEREAS, the City further desires to amend the Agreement to provide for drug testing for temporary employees and hazardous materials physicals for firefighters; and

WHEREAS, the Commissioner of the Department of Human Resources and the Chief Procurement Officer recommend the execution of Renewal and Amendment Number 1 with Caduceus Occupational Medicine in an amount not to exceed \$399,725.00.




THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to execute Renewal and Amendment Number 1 with Caduceus Occupational Medicine, for FC-6006007902, Pre-Employment Physicals, in an amount not to exceed Three Hundred Ninety-Nine Thousand Seven Hundred Twenty-Five Dollars and No Cents (\$399,725.00), to exercise the first renewal option, and provide for drug testing for temporary employees and hazardous materials physicals for firefighters. All contracted work shall be charged to and paid from Fund, Department Organization and Account numbers 5051 (WATER AND WASTEWATER REVENUE FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212003 (MEDICAL SERVICES PROVIDER) (\$45,216.00); 5501 (AIRPORT REVENUE FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212003 (MEDICAL SERVICES PROVIDER) (\$38,280.00); 6002 (GROUP INSURANCE FUND) 220203 (DHR INSURANCE ADMINISTRATION) 5212003 (MEDICAL SERVICES PROVIDER) (\$298,000.00); 1001 (GENERAL FUND) 230203 (AFR FIRE EMERGENCY MEDICAL SERVICES) 5212001 (CONSULTANT SERVICES) (\$18,229.00)
