**AS SUBSTITUTED BY FULL COUNCIL**

**AN ORDINANCE TO AMEND THE 2011 INTERGOVERNMENTAL GRANT FUND BUDGET, DEPARTMENT OF EXECUTIVE OFFICES, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$200,000.00 FROM THE FUND FOR CITIES OF SERVICE, INC. FOR THE CITIES OF SERVICE LEADERSHIP GRANT; TO AUTHORIZE THE MAYOR TO EXECUTE ALL NECESSARY GRANT AGREEMENTS; AND OTHER PURPOSES.**

**WHEREAS,** the City of Atlanta (“City”) has been selected to receive a grant award in the amount of \$200,000.00 from the Fund for Cities of Service, Inc., to provide funding for a Chief Service Officer position for a period of two years; and

**WHEREAS,** the Chief Service Officer will work under the direction of the Mayor’s Office, to help develop and implement the City’s comprehensive service plan; and

**WHEREAS,** \$100,000 of the grant award will be dedicated to the salary and benefits of the Chief Service Officer for the first year; the second installment of \$100,000 will be used for the same purpose in the second year, however, the City will not receive the second installment of \$100,000 until after it submits a first-year progress report and all other required periodic reports to the satisfaction of the Fund for Cities of Service, Inc.; and

**WHEREAS,** the City desires to anticipate and appropriate the grant award in the amount of \$200,000.00, and to enter into a Memorandum of Understanding with the Fund for Cities of Service, Inc. for purposes of the grant award.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:**

**Section 1:** That the Mayor is authorized to accept the grant award in the amount of \$200,000.00 from the Fund for Cities of Service, Inc., to provide funding for a Chief Service Officer position, and to enter into a Memorandum of Understanding with the Fund for Cities of Service, Inc. for purposes of the grant award

**Section 2:** That the 2011 Intergovernmental Grant Fund Budget is hereby amended as follows:
