




AUTHORIZING THE MAYOR OR HIS DESIGNEE (CHIEF FINANCIAL OFFICER) TO CREATE A TRUST FUND ACCOUNT FOR CITY OF ATLANTA COUNCIL DISTRICT 11 TO ACCEPT DONATIONS FOR THE "STILL STANDING, STILL STRONG: STRENGTHENING OUR COMMUNITIES & FAMILIES FOR SUCCESS " BACK TO SCHOOL EVENT; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta District 11 Councilmember, in partnership with Future Foundation and Greenbriar Mall, is hosting a "Still Standing, Still Strong: Strengthening Our Communities & Families for Success" back to school event at Greenbriar Mall on Saturday, July 31st; and

WHEREAS, the "Still Standing, Still Strong: Strengthening Our Communities & Families for Success " back to school event will include a mobile immunization and health screening unit, a Kidz Zone including face painting and clowns, give-a-ways (backpacks filled with age appropriate school supplies and books, etc.), library card registration booth, 30 vendors to showcase resources for youth and family, back to school fashion show, local entertainment, and workshops and possibly a celebrity guest; and

WHEREAS, the back to school event will contribute to District 11 children having the start of a successful school year, and

WHEREAS, members of the business community and individual citizens may want to donate funds to this event; and

WHEREAS, the District 11 residents would benefit from allowing the collection of donations from businesses and individual citizens in the community to assist in funding the back to school event.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA:

SECTION 1: That the Mayor or his designee (Chief Financial Officer) is authorized to create the appropriate City of Atlanta Council District 11 Trust Fund Account to allow for the deposit and expense of those funds to be collected in support of the "Still Standing, Still Strong: Strengthening Our Communities & Families for Success "back to school event.



SECTION 2: That any residual monies remaining in the account after the expenses of the named event will be donated to the Centers of Hope in City of Atlanta Council District 11, and the trust account will be deleted from the city's accounting system effective December 31, 2010.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived.
