

AN AMENDED ORDINANCE BY  
**COMMUNITY DEVELOPMENT/ HUMAN RESOURCES COMMITTEE**

**AN ORDINANCE AMENDING ATLANTA CODE OF ORDINANCES SECTION 110-59 BY CREATING A NEW SECTION (F) TO INCLUDE PROHIBITED ACTIVITIES IN SKATE PARKS; AND FOR OTHER PURPOSES.**

**WHEREAS**, the City of Atlanta (“City”) Code of Ordinances Section 110-59 (“Prohibited Conduct”) establishes rules for prohibited activities for individuals and groups wishing to utilize amenities in public parks managed by the Department of Parks, Recreation and Cultural Affairs; and

**WHEREAS**, ground was broken in 2010 on the Historic Fourth Ward Park (“Park”) located in District 2 of the City; and

**WHEREAS**, a skate park will be one of the amenities located within the Park; and

**WHEREAS**, the City wishes to amend Section 110-59 of the Code of Ordinances to prohibit certain activities within skate parks.

**THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:**

**Section 1:** Atlanta Code of Ordinances Section 110-59 entitled “Prohibited Conduct”, setting forth prohibited activities in City parks, shall be amended by:

- (1) Creating a new Section (f) entitled “Skate Parks”.
- (2) Prohibiting any activities in skate parks other than the intended usage.
- (3) Prohibiting the use of bicycles within the skate park area unless permitted by the Commissioner of Parks, Recreation & Cultural Affairs and signed as a permitted activity

Section 110-59 (f) shall read as follows:

(f) Skate Parks – for the purposes of this Ordinance, shall be defined as the hard surfaced area designed for the active pursuit of the intended activity - access pathways, or adjacent observation areas are not included.

- (1) No bicycles in the skate park.
- (2) No lying down in the skate park.
- (3) No eating in the skate park
- (4) No glass containers permitted in the skate park.

**Section 2:** All ordinances and resolutions in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of said conflict.
