AN ORDINANCE WAIVING THE CITY OF ATLANTA CODE OF ORDINANCE ARTICLE X, SECTION 2-1206 OF THE PROCUREMENT AND REAL ESTATE CODE, AUTHORIZING THE MAYOR AND HIS DESIGNEE TO ENTER INTO AN APPROPRIATE CONTRACTUAL AGREEMENT WITH WAYNE EVANS AUCTION COMPANY, INC., FOR LIQUIDATION SALE SERVICES FOR CITY HALL EAST SURPLUS PROPERTY BY AUCTIONEER SERVICES, ON BEHALF OF THE OFFICE OF ENTERPRISE AND ASSETT MANAGEMENT: ALL REVENUE GENERATED UNDER THE CONTRACT SHALL BE DEPOSITED TO FUND ACCOUNT AND CENTER NUMBER: 1A01 (GENERAL FUND), 491101 (SALE OF EQUIPMENT), B00001 (REVENUE CENTER).

WHEREAS, the City of Atlanta ("City") solicited Request for Proposals for qualified firms for FC-6007007930, to perform auctioneer services on behalf of the City; and

WHEREAS, the attached list of surplus is stored at City Hall East, as surplus property.

WHEREAS, Wayne Evans Auction will provide Liquidation sale services; and

WHEREAS, there is a need to expeditiously removed the property from City Hall East; and

WHEREAS, the Chief Procurement Officer has recommended that a professional service agreement be awarded to Wayne Evans; and

WHEREAS, Wayne Evans will receive compensation in the form of 50% of the unit price of the sale item.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HERBY ORDAINS,

SECTION 1: that the Mayor or his designee be and is herby authorized to enter into an appropriate contractual agreement with Wayne Evans Auction Company, Inc., for Liquidation Sale Services for City Hall East Surplus property by the Auctioneer Services, on Behalf of OEAM: All revenue generated under the contract shall be deposited to Fund Account and Center number: 1A01 (General Fund), 491101 (Sale of Equipment), B00001 (Revenue Center).



SECTION 2., that Wayne Evans Auction Company, Inc. will receive compensation in the form of 50% of the unit price of the sale item.

SECTION 3., that said agreement shall be for a period of three (3) months with no renewal options for the liquidation sale of surplus City Hall East property.

SECTION 4., that the City Attorney be and is hereby directed to prepare the appropriate contractual agreements for execution by the Mayor.

SECTION 5., that said contractual agreement shall not become binding upon the City, and the City shall incur no liability upon the same until such contract is approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk, and delivered to the contracting parties.
