



OPERATIONS AT HARTSFIELD-JACKSON ATLANTA  
INTERNATIONAL AIRPORT WITH A NUMBER OF  
AIRLINES CURRENTLY OPERATING AT HARTSFIELD-  
JACKSON ATLANTA INTERNATIONAL AIRPORT; AND  
FOR OTHER PURPOSES.**

**WHEREAS**, ABX Air, Inc., Air Transport International LLC., Alaska Airlines, Inc., American Eagle Airline Inc., Astar Air Cargo, Inc., Atlas Air, Inc., Capital Cargo International Airlines, Inc., Cargolux Airlines International S.A. Company, Cathay Pacific Airways Ltd. LLC., Chautauqua Airlines, Inc., China Airlines, Ltd., Comair, Inc., Compass Airlines, Inc., Express Jet Airlines, Inc., EVA Airways Corporation, Florida West, LLC., Freedom Airlines, Inc., Great Wall Airlines Company, Ltd., Jazz Air LP., KLM Royal Dutch Airlines, Mesa Airlines, Inc., Mesaba Aviation, Inc., Omni Air Holding, Inc., Pacific Wings LLC., Pinnacle Airlines, Inc., Shuttle America Corporation, SkyWest Airlines, Inc., Singapore Airlines Cargo PTE Ltd., Spirit Airlines, Inc., Trans States Airlines, Inc., Vision Airlines, Inc., and World Airways, Inc., (“Airlines”) are currently operating at Hartsfield-Jackson Atlanta International Airport (“Airport”) under agreements that expire on or before September, 20, 2010 and wish to continue to serve the Airport; and

**WHEREAS**, in furtherance of their plans to operate flights into and out of the Airport, Airlines desires to enter into Airport Use and License Agreements with the City of Atlanta (“City”) as carriers serving the Airport; and

**WHEREAS**, the Aviation General Manager believes that it is in the best interest of the Airport and the City to enter into Airport Use License Agreements with Airlines, as hereinafter set forth, and recommends the execution of such Agreements.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA**, that the Mayor be and hereby is authorized to execute on behalf of the City of Atlanta an appropriate Airport Use and License Agreement with ABX Air, Inc., Air Transport International LLC., Alaska Airlines, Inc., American Eagle Airline Inc., Astar Air Cargo, Inc., Atlas Air, Inc., Capital Cargo International Airlines, Inc., Cargolux Airlines International S.A. Company, Cathay Pacific Airways Ltd. LLC., Chautauqua Airlines, Inc., China Airlines, Ltd., Comair, Inc., Compass Airlines, Inc., Express Jet Airlines, Inc., EVA Airways Corporation, Florida West, LLC., Freedom Airlines, Inc., Great Wall Airlines Company, Ltd., Jazz Air LP., KLM Royal Dutch Airlines, Mesa Airlines, Inc., Mesaba Aviation, Inc., Omni Air Holding, Inc., Pacific Wings LLC., Pinnacle Airlines, Inc., Shuttle America Corporation, SkyWest Airlines, Inc., Singapore Airlines Cargo PTE Ltd., Spirit Airlines, Inc., Trans States



Airlines, Inc., Vision Airlines, Inc., and World Airways, Inc., each of which shall contain the following terms, conditions, and provisions:

- 1) A term effective as of September 21, 2010 and ending June 30 2018; provided that either party may terminate the agreement by giving at least 30 days prior written notice to the other party; and
- 2) A landing fee to be computed at the then current landing fee rate, which rate will be applied per 1,000 pounds of the FAA Maximum Certificated Gross Landing Weight of each passenger aircraft scheduled to land, and each cargo aircraft that actually lands, at the Airport. The landing fee rate shall be subject to adjustment from time to time at the discretion of the City acting through its Aviation General Manager. Such adjustments shall be to levels comparable to the landing fee rates charged similarly classified airlines at the Airport; and
- 3) Such other terms, conditions, and provisions as may be required by City ordinances or Federal regulations or which are otherwise deemed appropriate by the Aviation General Manager.

**BE IT FURTHER RESOLVED** that the City Attorney be and hereby is directed to prepare said Agreements for execution by the Mayor, with same to be approved as to form by the City Attorney.

**BE IT FINALLY RESOLVED** that said Agreements shall not become binding upon the City of Atlanta, and the City of Atlanta shall incur no obligation nor liability thereunder until the same have been signed by the Mayor and delivered to Airlines.
