A RESOLUTION TO AMEND RESOLUTION 10-R-0926 AUTHORIZING THE CREATION OF A COMMISSION TO DETERMINE AN APPROPRIATE HONOR MEMORIALIZING THE COMMITTEE FOR THE APPEAL FOR HUMAN RIGHTS AND THE ATLANTA STUDENT MOVEMENT, SO AS TO ADD A COMMISSION APPOINTMENT BY THE FLIPPER TEMPLE AME CHURCH; AND FOR OTHER PURPOSES.

WHEREAS, Resolution 10-R-0926 was adopted by Council on June 7, 2010 and approved by Mayor Kasim Reed on June 15, 2010; and,

WHEREAS, The original resolution did not provide for an appointment by the Flipper Temple AME Church; and,

WHEREAS, The Atlanta City Council wishes to correct this matter.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That an appointment by the Flipper Temple AME Church is added to the Commission to Honor the Committee for the Appeal for Human Rights and the Atlanta Student Movement.

Section 2: That the appointee to the Commission be a resident of the City of Atlanta and shall require Council confirmation.

Section 3: That upon the adoption and approval of this resolution, the Municipal Clerk is hereby directed to contact the Flipper Temple AME Church and request the name of an appointee, along with a copy of his/her resume, be submitted

Section 4: That all resolutions or parts of resolutions in conflict herewith are hereby rescinded.
