**A RESOLUTION IN SUPPORT OF THE TIGER II GRANT APPLICATION BEING SUBMITTED BY THE ATLANTA DEVELOPMENT AUTHORITY ON BEHALF OF THE ATLANTA BELTLINE PROJECT AND ATLANTA BELTLINE, INC., AND FOR OTHER PURPOSES.**

**WHEREAS**, Atlanta BeltLine, Inc. ("ABI") has been formed by The Atlanta Development Authority ("ADA") to perform certain redevelopment responsibilities for the City of Atlanta (the "City") with respect to the City of Atlanta Tax Allocation District Number Six – BeltLine (the "BeltLine TAD") and the BeltLine Redevelopment Plan (the "Redevelopment Plan") approved and adopted pursuant to Ordinance 05-O-1733 (the "BeltLine Ordinance") duly adopted by the City Council of the City on November 7, 2005, as approved by the Mayor of the City on November 9, 2005; and

**WHEREAS**, ABI has identified several projects through the approved Five Year Work Plan of the BeltLine TAD authorized by City Ordinance 06-O-1575, which includes the development of trail segments and pedestrian connections within the Atlanta BeltLine Corridor; and

**WHEREAS**, the Redevelopment Plan financing plan called for leveraging local and BeltLine TAD contributions with federal transportation funds as a part of funding the completion of several trail and pedestrian connection sections of the Atlanta BeltLine Project; and

**WHEREAS**, the United States Department of Transportation ("USDOT") has made available TIGER II grants for transportation projects of national and regional significance to be awarded on a competitive basis; and

**WHEREAS**, ABI partner organizations have already committed a significant portion of the required local match for the TIGER II grant; and

**WHEREAS**, The Atlanta Development Authority has agreed to submit an application for a TIGER II discretionary construction grant and associated planning grants to assist with the completion of trail segments and transit, housing and zoning studies within the Atlanta BeltLine Project corridor and associated pedestrian connections through surrounding communities.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:**

**SECTION 1:** The City Council of the City of Atlanta supports the TIGER II grant application being submitted by The Atlanta Development Authority on behalf of the Atlanta BeltLine Project.

**SECTION 2:** All resolutions and parts of resolutions in conflict herewith are hereby repealed for purposes of this ordinance only, and only to the extent of the conflict.
