


AN ORDINANCE TO AMEND CHAPTER 150, ARTICLE IV, DIVISION 3, SECTION 150-132 OF THE CITY OF ATLANTA CODE OF ORDINANCES TO AMEND THE PROVISIONS OF ORDINANCE NO. 99-O-0777, ADOPTED BY THE ATLANTA CITY COUNCIL ON DECEMBER 3, 2001, AND EFFECTIVE AS OF DECEMBER 12, 2001, SO AS TO REVISE SAID ORDINANCE BY DELETING SECTION 3 OF ORDINANCE NO. 99-O-0777 WHICH PROVIDED THAT PARKING METER FEE INCREASES FROM \$.50 PER HALF HOUR TO \$1.00 PER HALF HOUR WOULD NOT APPLY TO METERS LOCATED AROUND CITY HALL DOWNTOWN, GRADY HOSPITAL, ATLANTA MEDICAL CENTER, AND OTHER APPLICABLE HOSPITALS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta is in the process of implementing certain changes to its on-street parking meter program to facilitate the efficient operation of metered parking to benefit residents, business owners, visitors, patrons of the arts and all members of the public; and

WHEREAS, in implementing these changes, it is the desire of the City of Atlanta to increase the parking meter rates around City Hall Downtown, Grady Hospital, the Atlanta Medical Center, and other applicable hospitals from a rate of \$.50 per half hour to a rate of \$1.00 per half hour; and

WHEREAS, the increase in said rates will bring those rates in line with parking meter rates charged in all other parts of the City of Atlanta

NOW, THEREFORE, IT IS HEREBY ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

Section 1: That Ordinance No. 99-O-0777, adopted into law on December 12, 2001, for the purpose of increasing parking meter rates from \$.50 per half hour to \$1.00 per half hour be amended so as to delete the following provision contained in said ordinance:

“**Section 3:** That said increase shall not be implemented around City Hall Downtown, Grady Hospital, Atlanta Medical Center, and other applicable hospitals.”

Section 2: That upon deletion of said section, the parking meter rates charged for meters around City Hall Downtown, Grady Hospital, Atlanta Medical Center, and other applicable hospitals shall immediately be raised to \$1.00 per half hour.

Section 3: That the portion of the Editors Note that immediately follows Section 150-132 in the published version of the City of Atlanta Code of Ordinances referring to the meter fee not being implemented for Downtown City Hall and the referenced hospital be deleted so that as amended, the Editors Note will now read as follows:

Editor's note—

Section 2 of Ord. No. 2001-95, approved Dec. 12, 2001, states that the rates enumerated in § 150-132(b) shall become effective as new electronic meter heads are installed.

Section 4: Should it be found that any ordinance or parts of any ordinance are in conflict herewith, then those sections contained herein shall be deemed controlling.
