


**A RESOLUTION
BY TRANSPORTATION COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE RENEWAL AGREEMENT NO. 1 WITH STANDARD PARKING SOLUTIONS, FOR FC-6004007831, GROUND TRANSPORTATION TAXI STARTER SERVICES AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT, ON BEHALF OF THE DEPARTMENT OF AVIATION, IN AN AMOUNT NOT TO EXCEED \$467,716.00; ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FDOA 5501 (AIRPORT REVENUE FUND) 5212001 (CONSULTING/PROFESSIONAL SERVICES) 180315 (AVIATION GROUND TRANSPORTATION); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) owns and operates Hartsfield-Jackson Atlanta International Airport (“Airport”); and

WHEREAS, the City as owner and operator of the Airport desires to provide taxi starter dispatching services for airport customers seeking taxi services to the Central Business District of the City of Atlanta and surrounding areas; and

WHEREAS, the City entered into an Agreement with Standard Parking Solutions., FC-6004007831, for Ground Transportation Taxi Starter Services at the Airport on October 6, 2005 (the “Agreement”); and

WHEREAS, the base term of the Agreement is five (5) years with two (2) one (1) year renewal options at the sole discretion of the City; and

WHEREAS, the contract will expire on October 6, 2010; and

WHEREAS, Standard Parking Solutions., has performed the contracted services satisfactorily; and

WHEREAS, this first renewal option will continue the taxi starter services under the scope of the current Agreement; and

WHEREAS, the Aviation General Manager and the Chief Procurement Officer recommend the execution of Renewal No. 1 with Standard Parking Solutions; and

WHEREAS, A renewal for the first optional year and the continuation of the taxi services under the scope of the current agreement would be in the best interest of the City and the Department of Aviation in an amount not to exceed \$467,716.00 annually.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to execute Renewal Agreement No. 1 with Standard Parking Solutions for FC-6004007831, Ground Transportation Taxi Starter Management Services in an amount not to exceed \$467,716.00 annually.

BE IT FURTHER RESOLVED, that all contracted work shall be charged to and paid from FDOA 5501 (Airport Revenue Fund) 5212001 (Consulting/Professional Services) 180315 (Aviation Ground Transportation).

BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare an appropriate agreement for execution by the Mayor.

BE IT FINALLY RESOLVED, that the agreement will not become binding on the City and the City will incur no obligation nor liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to Standard Parking Solutions.
