

AN ORDINANCE BY COUNCILMEMBER YOLANDA ADREAN

AN ORDINANCE AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS TO REMOVE THE CURRENT PARKING RESTRICTIONS AND PARKING METERS ALONG BOTH SIDES OF EAST ANDREWS DRIVE, NW; AND FOR OTHER PURPOSES.

WHEREAS, East Andrews Drive, NW currently has two-hour parking restrictions on both sides of the street, although they have never been consistently enforced, and recently parking meters have also been installed per the approval of the Department of Public Works; and

WHEREAS, the east side of the street is bordered by at least 22 small businesses that are dependent on parking being available on the street, free of charge, since they have very limited parking for their employees and patrons; and

WHEREAS, specifically 22 of the businesses on East Andrews have a combined total of around 200 employees and only have an estimated 92 parking spaces on their private property for both employees and patrons; and

WHEREAS, if two-hour parking restrictions and meters stay in place on both sides of East Andrews, businesses in the area will be negatively impacted and in turn could be forced out of business; and

WHEREAS, an overwhelming majority of the businesses on East Andrews have signed a petition stating that they are opposed to two-hour parking restrictions and metered parking on both sides of the street, and that they believe if such restrictions remain in place it will be nearly impossible for them to survive.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA as follows:

Section 1: That the Department of Public Works remove two-hour parking restrictions and metered parking from both sides East Andrews Drive, NW.

Section 2: That all ordinances or parts of ordinances in conflict with the terms of this ordinance are hereby repealed.
