


A RESOLUTION AUTHORIZING THE REEMPLOYMENT OF RONDA K. GRAHAM AS SOLICITOR ASSISTANT ATTORNEY, SENIOR IN THE DEPARTMENT OF THE OFFICE OF THE CITY SOLICITOR AT SALARY GRADE 30, \$60,928.47 PURSUANT TO §3-505(C) OF THE CHARTER OF THE CITY OF ATLANTA; AND FOR OTHER PURPOSES

WHEREAS, the Office of the City Solicitor requires all courtrooms be staffed with two attorneys per courtroom to prosecute cases brought before the Municipal Court; and

WHEREAS, the Office of the City Solicitor is in need of immediate assistance by Solicitor Assistant Attorney, Senior already trained and competent to assume duties in the courtroom; and

WHEREAS, the Office of the City Solicitor FY2011 budget funded and Solicitor Assistant Attorney, Senior; and

WHEREAS, Section 3-505 authorizes that the City of Atlanta may reemploy a retiree which shall not exceed 520 business days, for the purpose of availing the City of particularized skills possessed by said retiree; and

WHEREAS, Section 3-505 (c) of the City Charter further provides that during the period of reemployment the retiree shall not acquire any civil service rights or any further pension rights, and shall not be required to make contributions to the pension fund; and

WHEREAS, Ronda K. Graham previously employed as a Solicitor Assistant Attorney, Senior, is available for re-hiring for services requiring expertise in prosecution; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows;

Section 1: That the Office of the City Solicitor of the City of Atlanta is authorized to re-employ Ronda K. Graham, Solicitor Assistant Attorney, Senior, as a full-time employee with City of Atlanta, at salary grade 30, \$60,928.47 as provided under §3-505 © of the Charter of the City of Atlanta, to be charged and paid from 1001.260101.5111001.265000.

Section 2: That all resolution and parts of resolutions in conflict with this resolution are hereby repealed.
