


A RESOLUTION AUTHORIZING THE REEMPLOYMENT OF KEITH D. DANIELS AS INVESTIGATOR, SENIOR IN THE DEPARTMENT OF THE OFFICE OF THE CITY SOLICITOR AT SALARY GRADE 17, \$38,471.88 PURSUANT TO §3-505(C) OF THE CHARTER OF THE CITY OF ATLANTA; AND FOR OTHER PURPOSES

WHEREAS, the Office of the City Solicitor requires that investigation functions be performed on all cases prior to prosecution; and

WHEREAS, the Office of the City Solicitor has not been able to effectively perform site visits, obtain evidence, and run criminal histories, as well as, conduct investigative duties deemed necessary by the prosecution; and

WHEREAS, the Office of the City Solicitor FY2011 budget funded an Investigator Senior, position; and

WHEREAS, Section 3-505 authorizes that the City of Atlanta may reemploy a retiree which shall not exceed 520 business days, for the purpose of availing the City of particularized skills possessed by said retiree; and

WHEREAS, Section 3-505 (c) of the City Charter further provides that during the period of reemployment the retiree shall not acquire any civil service rights or any further pension rights, and shall not be required to make contributions to the pension fund; and

WHEREAS, Keith D. Daniels previously employed as a Investigator, Senior, is available for re-hiring for services requiring expertise in prosecution; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows;

Section 1: That the Office of the City Solicitor of the City of Atlanta is authorized to re-employ Keith D. Daniels, Investigator, Senior, as a full-time employee with City of Atlanta, at salary grade 17, \$38,471.88 as provided under §3-505 © of the Charter of the City of Atlanta, to be charged and paid from 1001.260101.5111001.265000.

Section 2: That all resolution and parts of resolutions in conflict with this resolution are hereby repealed.
