


**A SUBSTITUTE RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR'S OFFICE TO APPLY FOR THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT 2010 LEAD-BASED PAINT HAZARD CONTROL AND THE LEAD HAZARD REDUCTION DEMONSTRATION GRANT PROGRAMS, IN AN AMOUNT NOT TO EXCEED TWO MILLION DOLLARS AND NO CENTS (\$2,000,000.00), TO CONTROL LEAD-BASED PAINT HAZARDS IN HOUSING UNITS WITHIN THE CITY OF ATLANTA; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") is interested in maximizing the number of housing units where lead hazards are controlled; and

WHEREAS, the U.S. Department of Housing and Urban Development ("HUD") has announced the availability of grant funds to be used to control lead-based paint hazards in private housing throughout the City; and

WHEREAS, the City desires to submit applications for funding through HUD's 2010 Lead-Based Paint Hazard Control and the Lead Hazard Reduction Demonstration Grant programs; and

WHEREAS, if received, the City will integrate the grants with housing rehabilitation, property maintenance, weatherization, housing related health hazard interventions, and other energy conservation activities and programs.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is hereby authorized to apply for the U.S. Department of Housing and Urban Development 2010 Lead-Based Paint Hazard Control and the Lead Hazard Reduction Demonstration Grant programs, in an amount not to exceed \$2,000,000.00, to be used to control lead-based paint hazards in private housing throughout the City of Atlanta.

BE IT FURTHER RESOLVED, that this grant will require 10% matching funds, with the matching funds to be charged to and paid from the following accounts:
