A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A RENEWAL AGREEMENT FOR CONTRACT FC-6006007929-D WITH HARTSFIELD-JACKSON TRANSPORTATION GROUP (H-JTG), A JOINT VENTURE COMPRISED OF JACOBS JJ&G INC., EDWARDS AND KELCEY, INC., AND BENCHMARK MANAGEMENT LLC., TO PROVIDE CONTINUED PROFESSIONAL, ARCHITECTURAL AND ENGINEERING DESIGN SERVICES FOR THE DEPARTMENT OF AVIATION ON A TASK ORDER BASIS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the "City") executed Contract with H-JTG FC-6006007929-D to provide professional architectural and engineering design services on a task order basis dated December 6, 2007 pursuant to Resolution 07-R-1462 for the Department of Aviation at Hartsfield-Jackson Atlanta International Airport; and

WHEREAS, the Contract was for an initial term of three years with a two year renewal option which may be exercised solely at the City's discretion; and

WHEREAS, the Director of Engineering and the Aviation General Manager have reviewed the required design services for calendar years 2011 and 2012 and have informed the Chief Procurement Officer that the Department of Aviation desires to exercise its option and renew the Contract for an additional two years.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, that the Mayor is authorized to execute a Renewal Agreement, on behalf of the City of Atlanta, with Hartsfield-Jackson Transportation Group.

BE IT FURTHER RESOLVED, that the City Attorney is hereby directed to prepare a Renewal Agreement for execution by the Mayor.

BE IT FURTHER RESOLVED, that the term of such Renewal Agreement will be two years.

BE IT FINALLY RESOLVED, that no Renewal Agreement will become binding on the City and the City will incur no liability or obligation under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form, and delivered to Hartsfield-Jackson Transportation Group.
