


AN ORDINANCE AMENDING THE 2011 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$40,000.00 FOR ONE GRANT AWARD FROM THE NATIONAL ENDOWMENT FOR THE ARTS FOR THE PURPOSE OF FUNDING THE OFFICE OF CULTURAL AFFAIRS CULTURAL EXPERIENCE PROJECT; TO AUTHORIZE THE MAYOR OR HIS DESIGNEE TO ACCEPT A \$40,000.00 GRANT AWARD FROM THE NATIONAL ENDOWMENT FOR THE ARTS SO AS TO FUND THE CULTURAL EXPERIENCE PROJECT IN CONSORTIUM WITH THE ATLANTA PUBLIC SCHOOLS; AND FOR OTHER PURPOSES.

Whereas, the Office of Cultural Affairs in the Department of Parks, Recreation & Cultural Affairs promotes the arts and cultural experiences for City of Atlanta residents just as the National Endowment for the Arts (NEA) does for the nation; and

Whereas, the Office of Cultural Affairs was recently awarded one grant from the NEA in the amount of \$40,000.00 for the Cultural Experience Project so as to assist in their mission of providing youth with exposure to the local arts and cultural performances in consortium with the Atlanta Public Schools creating an environment of learning in the arts for youth; and

Whereas, the Budget Commission of the City of Atlanta has recommended increasing estimated receipts in the 2011 (Intergovernmental Grant Fund) Budget by \$40,000.00.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the 2011 Intergovernmental Grant Fund Budget is hereby amended as follows:
