AN ORDINANCE AMENDING CHAPTER 114, PERSONNEL, ARTICLE 'V', CLASSIFICATION PLAN OF THE CODE OF ORDINANCES, CITY OF ATLANTA, GEORGIA ("CITY"), SO AS TO CREATE AN ACCOUNTANT ASSISTANT POSITION FOR THE ATLANTA POLICE DEPARTMENT ("DEPARTMENT") TO PROCESS PURCHASING FOR THE HIGH INTENSITY DRUG TRAFFICKING AREA ("HIDTA") TASK FORCE, AND FOR OTHER PURPOSES.

WHEREAS, the Department of Police ("Department") has been an active participant in the High Intensity Drug Trafficking Area (HIDTA) task force for over ten years; and

WHEREAS, the White House Office of National Drug Control Policy ("ONDCP") grants funding to local task forces responsible for disrupting and dismantling violent drug trafficking organizations; and

WHEREAS, as per Resolution 05-R-0680, the Atlanta Police Department ("Department") acts as the "pass through agency" to disburse payments for task force expenses that are completely federally funded; and

WHEREAS, the ONDCP has awarded the City grant #G10GA0003A, which was approved by Council under ordinance 10-O-1214, in the amount of four million, eight-hundred sixty-eight thousand, nine-hundred fifty-four dollars (\$4,868,954); to continue funding HIDTA task force initiatives; and

WHEREAS, the grant budget includes funding for the salary and benefits of a newly hired accountant assistant to process purchasing and assist in the administration of this grant; and

WHEREAS, the Department wishes to hire an accountant assistant in order to ensure timely, efficient, administration of the grant.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the following positions are hereby created in the Unclassified Service in the Department and Office indicated:
