BY FINANCE/EXECUTIVE COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A SOLE SOURCE PURCHASE WITH NORTHROP GRUMMAN AND PUBLIC SAFETY SYSTEMS INCORPORATED (“PSSI”), ON BEHALF OF THE DEPARTMENT OF POLICE (“DEPARTMENT”), FOR AUTOMATIC VEHICLE LOCATION FOR ONE-HUNDRED THIRTY (130) VEHICLES, IN AN AMOUNT NOT TO EXCEED TWO-HUNDRED TWENTY THOUSAND, SEVEN HUNDRED TEN DOLLARS (\$220,710). ALL COSTS SHALL BE CHARGED TO AND PAID FROM 7701 (TRUST FUND); 240101 (GENERAL LEDGER DEPARTMENT: APD CHIEF OF POLICE; 5421003 (EXPENSE ACCOUNT: EQUIPMENT \$5,000+); 1320000 (FUNCTION ACTIVITY NUMBER: CHIEF EXECUTIVE); 600234 (FEDERAL RICO); 69999 (FUNDING SOURCE); AND FOR OTHER PURPOSES.

WHEREAS, the Department of Police (“Department”) desires to purchase Automatic Vehicle Location (“AVL”) for one hundred thirty (130) police vehicles, to quickly and accurately track their positions, thereby improving dispatching, and to improve officer safety by speeding emergency assistance to personnel of the Atlanta Police Department (“Department”), and

WHEREAS, the Chief Procurement Officer has authorized a sole source procurement to a joint-venture by Northrop Grumman and Public Safety Systems Incorporated (“PSSI”) to provide the implementation of Automatic Vehicle Location (“AVL”) for the Atlanta Police Department in accordance with the City of Atlanta Code of Ordinances Section 2-1137; and

WHEREAS, the Chief of Police and the Chief Procurement Officer recommend that a sole source purchase be awarded to a joint-venture between Northrop Grumman and PSSI for the desired AVL in an amount not to exceed two-hundred twenty thousand, seven hundred ten dollars (\$220,710).

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to execute a sole source purchase on behalf of the Department of Police with Northrop Grumman and PSSI for the purchase of AVL for Police Department vehicles, in an amount not to exceed two-hundred twenty thousand, seven hundred ten dollars (\$220,710).

BE IT FURTHER RESOLVED, that all costs shall be charged to and paid from a grant from 7701 (Trust Fund); 240101 (General Ledger Department: APD Chief of Police); 5421003 (Expense Account: Equipment \$5,000+); 1320000 (Function Activity Number: Chief Executive); 600234 (Federal RICO); 69999 (Funding Source).
