

**A SUBSTITUTE #3 ORDINANCE BY COMMITTEE ON COUNCIL**

**TO AMEND THE 2001 CITY OF ATLANTA PRECINCTS AND POLLING PLACES IN PRECINCTS 02A, 02C, 03H, 05B, 06A, 07A, 07N, 08C, 08H, 08J, 09A, 10P AND 11J TO MAKE TEMPORARY OR PERMANENT RELOCATIONS AS A RESULT OF SCHEDULED AND/OR COMPLETED RENOVATIONS OR CONFLICTING SCHEDULED EVENTS AT THE VOTING FACILITY, EXISTING FACILITY NO LONGER AVAILABLE AND BANK FORECLOSURE OF A VOTING FACILITY; AND FOR OTHER PURPOSES.**

**WHEREAS**, the 2001 Precincts and Polling Places Ordinance, dated October 24, 2001, was adopted November 5, 2001, and;

**WHEREAS**, such Precincts and Polling Places Ordinance has previously been amended by action of the City Council on May 20 2002, July 15 2002, September 3 2002, October 21 2002, November 18 2002, September 15 2003, October 20 2003, April 19 2004, July 19 2004, November 01 2004, September 06 2005, November 07 2005, June 05 2006, July 05 2006, September 05 2006, October 02 2006, December 04 2006, February 05 2007, March 19 2007, May 21 2007, September 04 2007, January 22 2008, July 07 2008, November 03 2008, May 04 2009, June 01 2009, August 17 2009, October 19 2009, May 03 2010 and ;

**WHEREAS**, the Fulton County Board of Registration and Elections has approved changes to City of Atlanta Precincts/Polling Places 02A, 02C, 03H, 05B, 06A, 07A, 07N, 08C, 08H, 08J, 09A, 10P and 11J to make temporary or permanent relocations as a result of scheduled and/or completed renovations or conflicting scheduled events at the voting facilities, existing facility no longer available and bank foreclosure of a voting facility and;

**WHEREAS**, all affected voters will be notified of these changes by the Fulton County Office of Registration and Elections accordingly and;

**WHEREAS**, the governing authority of the City of Atlanta, the Atlanta City Council, believes that ratification of these changes should be made by this Body.

**NOW THEREFORE BE IT ORDAINED** that the Atlanta City Council does hereby ratify the previous authorization and approval by the Fulton County Board of Registration and Elections of polling place changes in Precincts **02A, 02C, 03H, 05B, 06A, 07A, 07N, 08C, 08H, 08J, 09A, 10P and 11J** within the City of Atlanta/Fulton County; and

**BE IT FINALLY ORDAINED** that the Atlanta City Council does hereby Amend the 2001 Precincts and Polling Places Ordinance, dated October 24, 2001, and Adopted November 5, 2001 which was codified as Section 66-2 of the City of Atlanta Code of Ordinances and adopted by reference, by adding the recent changes to Precincts/Polling Places **02A, 02C, 03H, 05B, 06A, 07A, 07N, 08C, 08H, 08J, 09A, 10P and 11J** to make temporary or permanent relocations as a result of scheduled and/or completed renovations or conflicting scheduled events at the voting facilities, existing facility no longer available and bank foreclosure of a voting facility, all of



which are reflected or incorporated in the July 19, 2010 Revision to the 2001 Precincts and Polling Places Ordinance, identified as Attachment I to this ordinance, with certain particular changes described by the further attachments identified as, **Exhibits A, B, C, D, E, F, G, H, I, J, K, L and M** all being made a part hereof and noted as follows:

**SECTION 1.** To amend **Precinct/Polling Place 02A located at Centennial YMCA, 555 Lucky Street, NW** by permanently moving said precinct to **Centennial Elementary School, located at 531 Luckie Street, NW** due to the existing facility no longer being available for voting as identified in Exhibit G (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 3). Voters will be notified of their voting location by first-class mail.

**SECTION 2.** To amend **Precinct/Polling Place 02C located at Cosby Spears High-rise, 355 North Avenue, NE** by temporarily moving said precinct to **Grace United Methodist Church** due to scheduled renovations at the existing facility as identified in Exhibit J (Pages 1-2). The proposed facility is accessible to the disabled and is 0.5 miles from the existing facility. The new polling place is indicated in Attachment I (page 3). Voters will be notified of their voting location by first-class mail.

**SECTION 3.** To amend **Precinct/Polling Place 03H located at Allen Temple AME Church, 1625 Joseph Boone Boulevard, NW** by permanently moving said precinct back to its original facility **Walter F. White School, located at 1890 Detroit Avenue, NW** due to renovations at the original facility being completed as identified in Exhibit H (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 6). Voters will be notified of their voting location by first-class mail.

**SECTION 4.** To amend **Precinct/Polling Place 05B located at Columbia Village Sr. Residence, 125 Logan Street, SE** by permanently moving said precinct back to its original facility **Cook Elementary School, located at 211 Memorial Drive, SE** due to renovations being completed as identified in Exhibit E (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the temporary facility. The new polling place is indicated in Attachment I (page 10). Voters were immediately notified of their voting location by first-class mail.

**SECTION 5.** To amend **Precinct/Polling Place 06A located at Tenth Street High-rise, 150 Tenth Street, NE** by temporarily moving said precinct to **Grady High School, 929 Charles Allen Drive, NE** due to scheduled renovations at the existing facility as identified in Exhibit K (Pages 1-2). The proposed facility is accessible to the disabled and is 0.7 miles from the existing facility. The new polling place is indicated in Attachment I (page 12). Voters will be notified of their voting location by first-class mail.

**SECTION 6.** To amend **Precinct/Polling Place 07A located at Sara Rawson Smith School, 370 Old Ivy Road, NE** by temporarily moving said precinct to **Sara Smith Intermediate School, located at 4141 Wieuca Road, NE** due to scheduled major renovations at the existing facility as identified in Exhibit A (Pages 1-2). The proposed facility is accessible to the disabled



and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 14). Voters were notified of their voting location by first-class mail.

**SECTION 7.** To amend **Precinct/Polling Place 07A located at Sara Smith Intermediate School, 4141 Wieuca Road, NE** by moving said precinct back to its original facility **Sara Rawson Smith School, 370 Old Ivy Road, NE** due to renovations being completed as identified in Exhibit I (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 14). Voters will be notified of their voting location by first-class mail.

**SECTION 8.** To amend **Precinct/Polling Place 07N located at Marian Road High-rise Apts., 760 Sidney Marcus Boulevard, NE** by temporarily moving said precinct to **Country Inn & Suites, 800 Sidney Marcus Boulevard, NE** due to scheduled renovations at the existing facility as identified in Exhibit L (Pages 1-2). The proposed facility is accessible to the disabled and is 0.4 miles from the existing facility. The new polling place is indicated in Attachment I (page 15). Voters will be notified of their voting location by first-class mail.

**SECTION 9.** To amend **Precinct/Polling Place 08C located at Northwest Presbyterian Church, 4300 Northside Dr., NW** by temporarily moving said precinct to **W. T. Jackson Primary School, located at 4191 Northside Drive, NW** due to a scheduled event at the existing facility as identified in Exhibit B (Pages 1-2). The proposed facility is accessible to the disabled and is less than one mile from the existing facility. The new polling place is indicated in Attachment I (page 16). Voters were notified of their voting location by first-class mail.

**SECTION 10.** To amend **Precincts/Polling Places 08H and 08J located at North Atlanta High School, 2875 Northside Drive, NW** by temporarily moving said precincts to **Northside United Methodist Church, located at 2799 Northside Drive, NW** due to scheduled major renovations at the existing facility as identified in Exhibit C (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling places are indicated in Attachment I (pages 16-17). Voters were notified of their voting locations by first-class mail.

**SECTION 11.** To amend **Precinct/Polling Place 09A located at Marietta Road High-rise, 2295 Marietta Road, NW** by temporarily moving said precinct to **Bolton Academy Elementary School, 2268 Adams Drive, NW** due to scheduled renovations at the existing facility as identified in Exhibit M (Pages 1-2). The proposed facility is accessible to the disabled and is 0.5 miles from the existing facility. The new polling place is indicated in Attachment I (page 18). Voters will be notified of their voting location by first-class mail.

**SECTION 12.** To amend **Precinct/Polling Place 10P located at Pleasant Hill Baptist Church, 745 Bolton Road, NW** by permanently moving said precinct back to its original facility **Towns Elementary School, 760 Bolton Road, NW** due to the temporary facility undergoing a bank foreclosure on August 02, 2010 as identified in Exhibit F (Pages 1-2). The proposed facility is accessible to the disabled and is less than a mile from the existing facility. The new polling place is indicated in Attachment I (page 21). Voters were immediately notified of their voting location by first-class mail.





**PRECINCT 02A**




