COMMISSIONER OF CORRE), 5222002 (REPAIR & MAINTENANCE-EQUI), 1320000 (CHIEF EXECUTIVE), 91491 (JAIL FUND ADMINISTRATION), 9996 (JAIL ADMIN N CONST); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") entered into an agreement with Police Central, Inc. for FC-4782, Jail Management Systems; and

WHEREAS, PCI has been involved in the management of jails for many years and recognizes the integral part software plays in the safe and efficient management of facilities and will therefore make every effort to provide effective and timely support to assure the most uninterrupted performance possible which includes round the clock, 365 day support from its Atlanta Office as well as on-site assistance whenever necessary to solve technical or operational issues with the provision of toll-free 24 hour telephone numbers; and


WHEREAS, PCI customers with a current Maintenance and Support Agreement receive periodic software upgrades and improvements at no extra cost and for the Agreement price the ACDC will receive full 24x7x365 in support services at no additional charge and no hourly service fees; and

WHEREAS, PCI under the Agreement, will provide modifications as mandated by the State of Georgia and;

WHEREAS, the Chief of Corrections and the Chief Procurement Officer recommends the Agreement for FC-4782 PCI, Jail Management Systems.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA AS FOLLOWS:

The Mayor or his designee be and is hereby authorized to enter into a maintenance agreement with Police Central, Inc., pursuant to FC-4782, Jail Management Systems, for a period of one (1) year in FY11, in an amount not to exceed two hundred thousand, one hundred seventy-seven dollars and no cents (\$200,177.00) to be paid in four (4) quarterly installments of fifty thousand forty-four dollars and twenty five cents (\$50,044.25).



BE IT FURTHER RESOLVED, that the Chief Procurement Officer is directed to prepare the appropriate documents for execution by the Mayor, and the Agreement shall be approved by the City Attorney or his/her designee as to form.

BE IT FURTHER RESOLVED, that the Agreement shall be approved by the City Attorney or his/her designee as to form.

BE IT FURTHER RESOLVED, that the Agreement shall not become binding upon the City and the City shall incur no obligation or liability hereunder until the same has been signed by the Mayor or his/her designee and delivered to Police Central, Inc.

BE IT FINALLY RESOLVED, that all costs shall be charged to 7701 (Trust Fund), 090101 (Cor. Commissioner of Corre), 52220022 (Repair & Maintenance-Equi), 1320000 (Chief Executive), 91491 (Jail Fund Administration), 9996 (Jail Admin N Const)
