AN ORDINANCE TO ACTIVATE SECTION 2-49 (CURRENTLY DESIGNATED AS "RESERVED") OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA, GEORGIA SO AS TO CODIFY RULE IV OF THE RULES FOR THE CONDUCT OF BUSINESS OF THE ATLANTA CITY COUNCIL WHICH PERTAINS TO THE ASSIGNMENT OF COUNCIL MEMBER OFFICES; TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, the Committee on Council seeks to codify rules of council which are not otherwise contained in either the City Charter or the City Code of Ordinances; and

WHEREAS, Rule IV of the Rules for the Conduct of Business of the Atlanta City Council which pertains to the assignment of council member offices, is one of such rules.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

Section 1: Section 2-49 (currently designated as "Reserved") of the Code of Ordinances of the City of Atlanta, Georgia, is hereby activated and shall provide as follows:

Sec. 2-49. Assignment of council member offices.

(a) Assignment of space. In the event that a General Election, Run-off Election, Special Election or required appointment by council result in council member office space to become available:

The director of council staff shall deliver to each council member, a notice of office availability. The notice shall request each council member to respond within one week whether they wish to be considered for assignment to newly available office space. Those seeking reassignment shall indicate her/his office space priorities depending on the number of offices available.

Assignment to newly available office space shall be determined by seniority based upon continuous years of service, without interruption. In the event council members have equal years of uninterrupted service, the director shall have council members draw lots to break the tie.

(b) Vacating council member offices. All city property including but not limited to furniture, office machines, equipment, communication devices, office supplies, decorations, keys, parking and garage cards and badges, digital and paper files, books, reports and other records, shall remain and continue to be assigned to the district or post regardless of office assignment.

Section 2: All ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of any such conflict.
