AN ORDINANCE TO ACTIVATE SECTION 2-48 (CURRENTLY DESIGNATED AS "RESERVED") OF THE CODE OF ORDINANCES OF THE CITY OF ATLANTA, GEORGIA SO AS TO CODIFY RULE XIV OF THE RULES FOR THE CONDUCT OF BUSINESS OF THE ATLANTA CITY COUNCIL WHICH PERTAINS TO THE USE AND ASSIGNMENT OF THE CITY COUNCIL CHAMBER AND THE COUNCIL COMMITTEE ROOMS; TO WAIVE CONFLICTING ORDINANCES; AND FOR OTHER PURPOSES.

WHEREAS, the Committee on Council seeks to codify rules of council which are not otherwise contained in either the City Charter or the City Code of Ordinances; and

WHEREAS, Rule XIV of the Rules for the Conduct of Business of the Atlanta City Council which pertains to the use and assignment of the city council chamber and the council committee rooms, is one of such rules.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

**Section 1:** Section 2-48 (currently designated as "Reserved") of the Code of Ordinances of the City of Atlanta, Georgia, is hereby activated and shall provide as follows:

**Sec. 2-48. Use and assignment of the city council chamber and the council committee rooms.**

(a) Any group or organization must receive permission from the office of the president of council to use the council chamber. No use of the council chamber shall be allowed at the time scheduled for regular or special council meetings.

(b) The priority of the use and assignment of the council chamber and the committee rooms shall be as follows:

- (1) All standing committees of council;
- (2) Individual council members;
- (3) All city boards and commissions;
- (4) City departments or community organizations; and
- (5) Any general city staff for meetings or events.

**Section 2:** All ordinances or parts of ordinances in conflict herewith are hereby waived to the extent of any such conflict.
