**A SUBSTITUTE ORDINANCE
BY COUNCILMEMBER CLETA WINSLOW**

AN ORDINANCE AMENDING THE 2010 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF PARKS, RECREATION AND CULTURAL AFFAIRS, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF \$39,545.00 FOR A GRANT AWARD FROM THE GOVERNOR'S OFFICE FOR CHILDREN AND FAMILIES TO FUND THE ATLANTA GUN VIOLENCE PREVENTION PROGRAM; AND FOR OTHER PURPOSES.

WHEREAS, ordinance 10-O-1237 adopted by the Atlanta City Council on July 6, 2010 and approved by the Mayor on July 14, 2010 anticipated and appropriated a grant award in the amount of \$39,494.00 from the Governor's Office for Children and Families to fund the implementation of the Atlanta Gun Violence Prevention program; and

WHEREAS, the City of Atlanta ("City") has been notified that additional grant funds in the amount of \$39,545 are available to supplement the original grant award to fund more supplies and equipment for the Atlanta Gun Violence Program, and

WHEREAS, the City desires to accept and anticipate and appropriate the additional grant funds in the amount of \$39,545.00.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the City is hereby authorized to accept a grant award in the amount of \$39,545.00 from the Governor's Office for Children and Families, for the purpose of funding the Atlanta Gun Violence Prevention program.

SECTION 2: That the 2010 (Intergovernmental Grant Fund) Budget, Department of Parks Recreation and Cultural Affairs and Department of Police, is hereby amended as follows:
