



**A RESOLUTION
BY TRANSPORTATION COMMITTEE**

A RESOLUTION AUTHORIZING THE MAYOR TO AWARD AND EXECUTE AN AGREEMENT WITH HSS, INC. FOR FC-5051, GATE GUARD SERVICES AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT, ON BEHALF OF THE DEPARTMENT OF AVIATION, IN AN AMOUNT NOT TO EXCEED \$3,018,386; ALL CONTRACTED WORK SHALL BE CHARGED TO AND PAID FROM FDOA 5501 (AIRPORT REVENUE FUND) 5212001 (CONSULTING/PROFESSIONAL SERVICES) 180313 (AVIATION SECURITY) 7563000 (AIRPORT); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta ("City") owns and operates Hartsfield-Jackson Atlanta International Airport ("Airport"); and

WHEREAS, the City, as owner and operator of the Airport, must ensure compliance with all Transportation Security Regulations (TSR); and

WHEREAS, TSR 1542 requires airport operators to provide for the safety and security of persons and property against acts of criminal violence, aircraft piracy, and the introduction of an unauthorized weapon, explosive or other devices onto an aircraft; and

WHEREAS, the City did solicit Request for Proposals for FC-5051, Gate Guard Services at Hartsfield-Jackson Atlanta International Airport, to perform security access control to designated areas and related security services; and

WHEREAS, after a review and evaluation of the proponent's qualifications, the Aviation General Manager and the Chief Procurement Officer recommend the award and execution of an agreement with HSS, Inc., in an amount not to exceed \$3,018,386; and

WHEREAS, the base term of the Agreement is for one (1) year with four (4) consecutive one (1) year renewal options at the sole discretion of the City; and

WHEREAS, \$1,509,193 of the total \$3,018,386 of the contractual amount is appropriated in the department's Fiscal Year 2010/2011 Budget and the remaining \$1,509,193 will be established in the department's Fiscal Year 2011/2012 Budget.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor is authorized to award and execute a contract with HSS, Inc., for FC-5051, Gate Guard Services, in an amount not to exceed \$3,018,386.



BE IT FURTHER RESOLVED, that the initial term will be for a period of one (1) year with four (4) consecutive one (1) year renewal options and the renewal must contain the following contingencies:


1. HSS, Inc. is initially authorized to perform Gate Guard Services through June 30, 2011, in an amount not to exceed \$1,509,193 for the Department of Aviation (DOA) Fiscal Year 2010/2011 Budget only.
2. The initial agreement for Gate Guard Services for the period of July 1, 2011 through December 22, 2011, is contingent upon the establishment of the DOA Fiscal Year 2011/2012 Budget containing funds in the amount of \$1,509,193 for the payment of Gate Guard Services.
3. If such additional budgeted funds are authorized by appropriate legislative action, the Aviation General Manager or his designee will provide to HSS, Inc., prior written notice that it is authorized to continue to provide Gate Guard Services for the DOA for the period from July 1, 2011, through December 22, 2011.
4. If such additional budgeted funds are not authorized, this initial agreement and the provision of Gate Guard Services by HSS, Inc. will be suspended until such time that the funding is available and appropriated.

BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare an appropriate agreement for execution by the Mayor, to be approved as to form by the City Attorney.

BE IT FURTHER RESOLVED, that all contracted services shall be charged to and paid from FDOA 5501 (Airport Revenue Fund) 5212001 (Consulting/Professional Services) 180313 (Aviation Security) 7563000 (Airport).

BE IT FINALLY RESOLVED, that the Contract will not become binding on the City and the City will incur no obligation nor liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved as to form by the City Attorney and delivered to HSS, Inc.
