AN ORDINANCE AMENDING THE 2011 (WIA ADULT JOB TRAINING FUND) BUDGET, ATLANTA WORKFORCE DEVELOPMENT AGENCY, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ONE MILLION SIX HUNDRED SEVENTY NINE THOUSAND SIX HUNDRED TWO DOLLARS (\$1,679,602.00) IN THE WORKFORCE INVESTMENT ACT ADULT FUND FROM THE GEORGIA DEPARTMENT OF LABOR, TO PROVIDE JOB TRAINING AND OTHER SKILLS TO LOCAL ADULT WORKERS; AND FOR OTHER PURPOSES.

WHEREAS, the purpose of the Workforce Investment Act (“WIA”) is to provide workforce investment activities through statewide and local workforce systems in order to increase employment, retention, the earnings of citizens, and the attainment of occupations skill for participants, thereby improving the quality of the workforce; and

WHEREAS, the Georgia Department of Labor (“GDOL”) has awarded the City of Atlanta (“City”), through the Atlanta Workforce Development Agency (“AWDA”), a grant in the amount of One Million Six Hundred Seventy Nine Thousand Six Hundred Two Dollars (\$1,679,602.00), to provide training funds for adult workers who need to upgrade or acquire skills to obtain full-time employment at liveable wages; and

WHEREAS, AWDA recommends increasing receipts in the 2011 (Job Training Fund) Budget by One Million Six Hundred Seventy Nine Thousand Six Hundred Two Dollars (\$1,679,602.00) in the WIA Adult Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA , as follows:

Section 1: That the 2011 (WIA Adult Job Training Fund) Budget is hereby amended as follows:
