WHEREAS, the City of Atlanta (“City”) solicited bids for Project No. FC- 5130; Runway 27R Extension Site Preparation (“Project”), on behalf of the Department of Aviation; and

WHEREAS, the City received five bids for the Project; the first third lowest bidders were deemed non-responsive and non-responsible by the City’s Department of Procurement and, accordingly, preclude from consideration for the award of an Agreement for the Project; and

WHEREAS, the Aviation General Manager and the Chief Procurement Officer have recommended that an Agreement for the Project be awarded to the most responsive and responsible bidder, C.W. Matthews Contracting Company Inc. (“Matthews”), whose bid met the requirements and criteria set forth in the Instructions to Bidders, in an amount not to exceed \$15,981,587.02.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor is authorized to execute an Agreement for the Project with Matthews, on behalf of the Department of Aviation, in an amount not to exceed \$15,981,587.02.

BE IT FURTHER RESOLVED, that Matthews is expected to achieve substantial completion of the Project within 180 calendar days from the date of the Notice to Proceed.

BE IT FURTHER RESOLVED, that the City Attorney is directed to prepare an Agreement for execution by the Mayor.



BE IT FURTHER RESOLVED, that all contracted work will be charged to and paid for from PTAE0: 18100301 (Airfield-General Improvements) 104 (Task) 550591336 (DOA PFC Revenue 96AA) 5414002 (Facilities Other Than Bldgs) and FDOA: 5505 (Airport Passenger Facility Charge Fund) 180201 (DOA Aviation Capital Planning & Development) 5414002 (Facilities Other Than Bldgs) 7563000 (Airport) 100301 (Airfield-General Improvements) 91336 (DOA PFC Revenue 96AA).

BE IT FINALLY RESOLVED, that the Agreement will not become binding upon the City and the City will incur no obligation or liability under it until it has been executed by the Mayor, attested to by the Municipal Clerk, approved by the City Attorney as to form and delivered to Matthews.
