


**AN ORDINANCE TO AMEND CHAPTER 16, ZONING, SECTION 16-02.019(3) TO ADD ATWOOD ROAD, NE TO THE LIST OF EXCEPTIONS FROM THE STREET NUMBERING SYSTEM; AND FOR OTHER PURPOSES.**

**WHEREAS**, the residences on Atwood Road in the Northeast quadrant were constructed in the 1920's and 30's prior to annexation into the City and the creation of the street numbering system related to the quadrant lines as set forth in the City of Atlanta Zoning Ordinance in Sec. 16-02.019(1) and Sec. 16-02.019(2); and

**WHEREAS**, Sec. 16-02.019 (3) requires all numbering of houses on a street to be consecutive and related to the quadrant lines set forth in Sec. 16-02.019(1) and Sec. 16-02.019(2); and

**WHEREAS**, the historical numbering references for certain residences on Atwood Road in the Northeast quadrant do not conform to the consecutive numbering requirement set forth in Sec. 16-02.019 (3); and

**WHEREAS**, after discovery of certain non-conforming addresses and a survey of the addresses on Atwood Road, it appears that at least two house numbers which have identified certain parcels of real property on Atwood Road for over 70 years would have to be changed at great trouble and expense to their owners in order to conform to Sec. 16-02.019(1) and Sec. 16-02.019(2); and

**WHEREAS**, those residents on Atwood Road, who have these nonconforming addresses, have not reported any problem with emergency services or the United States Post Office being unable to locate the properties because of use of the non-conforming street numbers that existed before Atwood Road became a part of the City; and

**WHEREAS**, those residents on Atwood Road, who have these nonconforming addresses, have requested that this exception to the City's addressing procedure be made through the enactment of this legislation;

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:**

**Section 1:** The Code of Ordinances, City of Atlanta, Georgia, is hereby amended by adding a section be numbered Sec. 16-02.019 (3)(j) to include this segment of Atwood Road in the list of streets which are exempted from the requirement of consecutive numbering, and which reads as follows:

- (j) Atwood Road, NW running from Brentwood Drive, NE to East Wesley Road.

**Section 2:** Those operational departments of the City responsible for the notation and documentation of street addresses are authorized to allow these non-conforming



addresses to identify the parcels of real property on Atwood Road in the manner in which such numbering existed prior to annexation of Atwood Road into the City of Atlanta and to take such action as necessary to cause this ordinance to become effective.

**Section 3:** This ordinance shall become effective immediately upon signing by the Mayor or as otherwise provided by operation of law.
